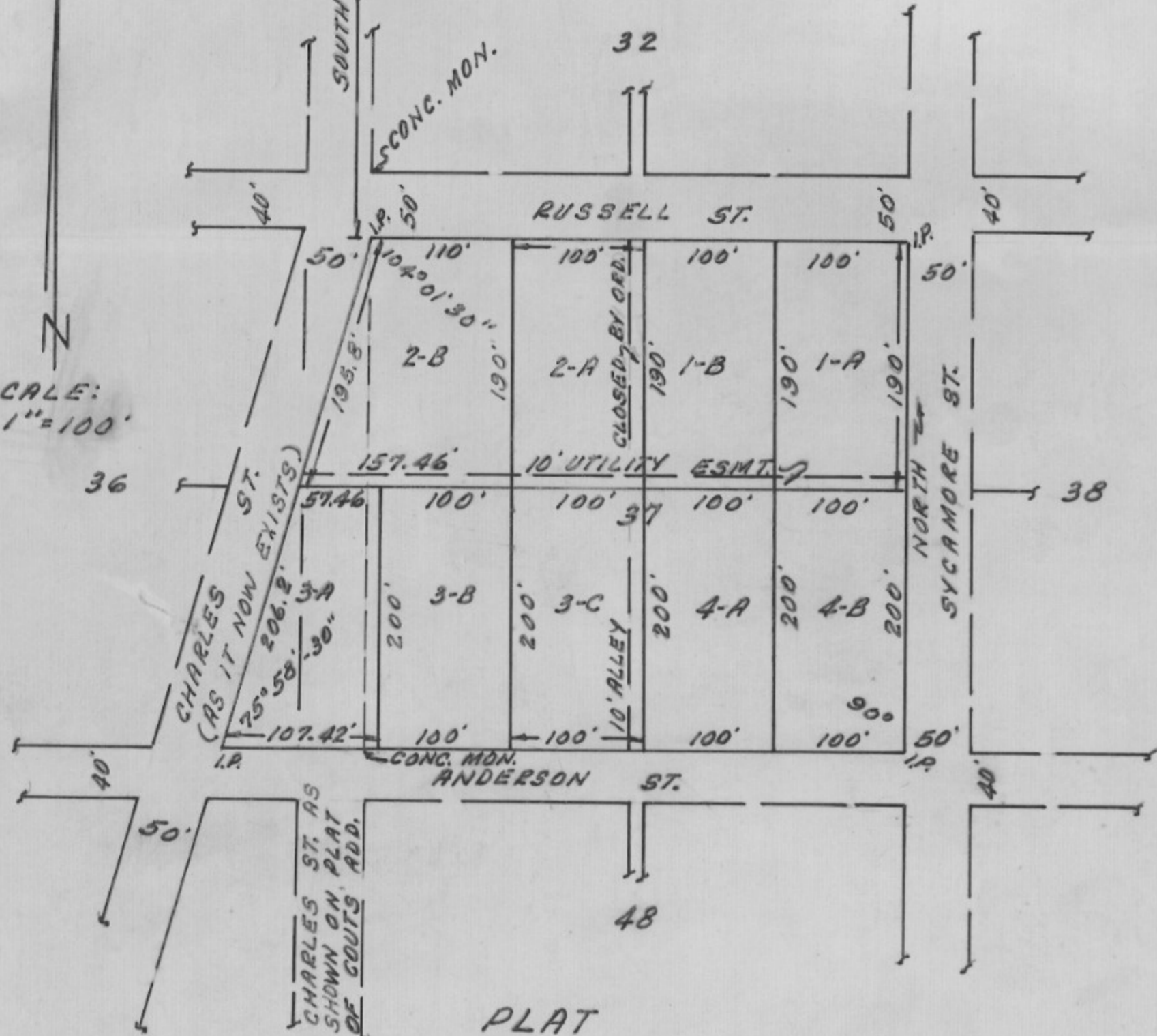


S.N.W. COR.
