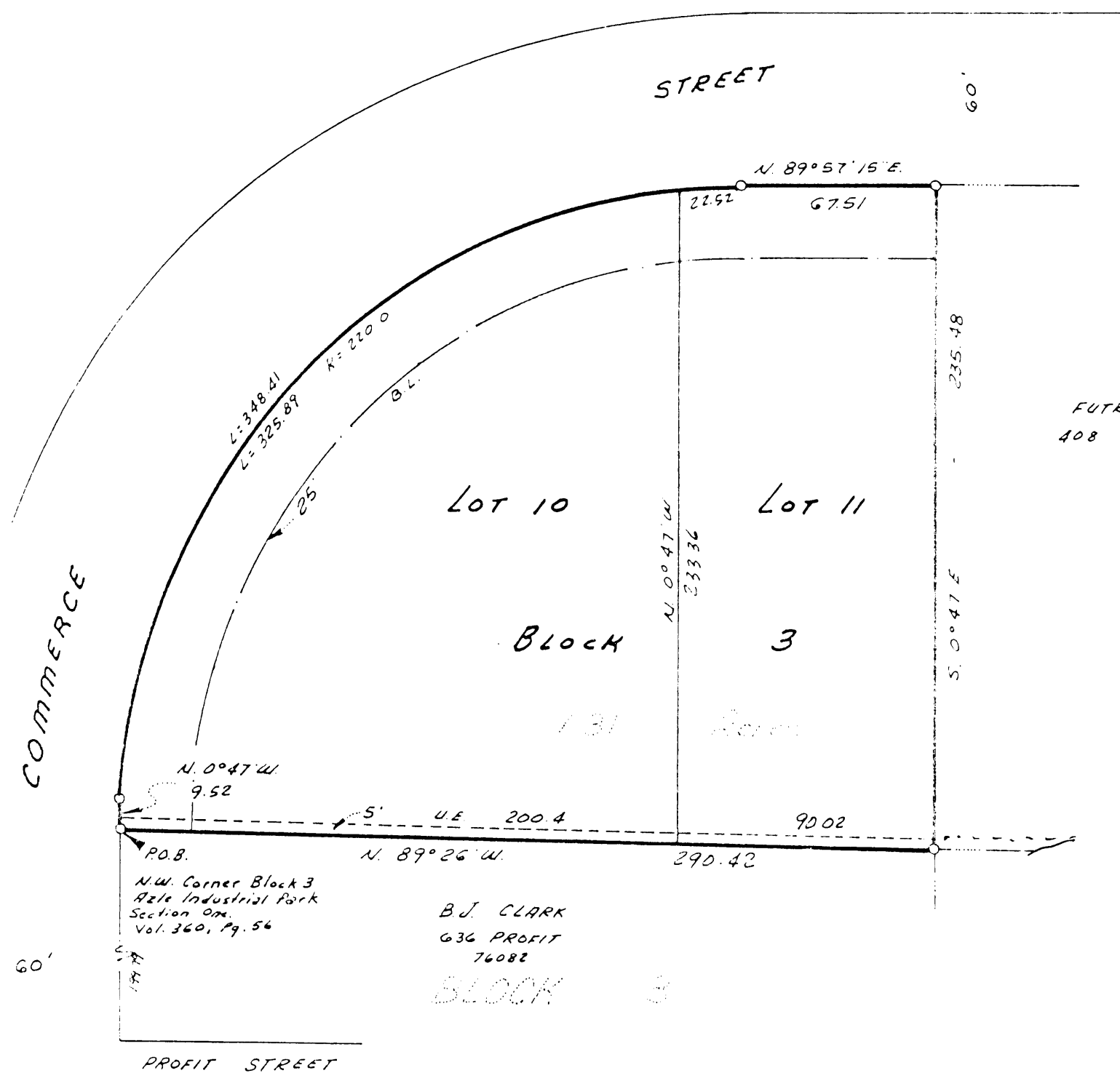

Whereas, the State Bank being the owner of a tract of land out of the T. & P. RR. Co. Survey, No. 7, Abstract No. 1431, Parker County, Texas, and being described by metes and bounds as follows:

BEGINNING at an iron pin in the northwest corner of block 3, Azle Industrial Park, Section Two, as mentioned in Vol. 101, Pg. 20, Plat Records, Parker County, Texas, for the Point of Beginning.

THENCE N. 00°47'W., 9.52 feet along the east line of Commerce Street to an iron pin or the starting point to the right;

THENCE with said course in the east line of Commerce Street an arc length of 348.41 feet and a radius of 220.0 feet to an iron pin in the south line of Commerce Street for the end of said corner;

THENCE N. 89°57'15\" E., 67.51 feet along the south line of Commerce Street to an iron pin;

THENCE S. 00°47' E., 235.48 feet to an iron pin;

THENCE N. 89°26' W., 290.42 feet to the Point of Beginning and containing 1.31 acre of land more or less.

NOW TO BE OPEN, KNOW ALL MEN BY THESE PRESENTS:

That Azle State Bank does hereby adopt this plat as lots 10 and 11, block 3, Azle Industrial Park, and does hereby, in addition to the City of Azle, Parker County, Texas, and does hereby dedicate to the public use forever the streets and easements shown thereon.

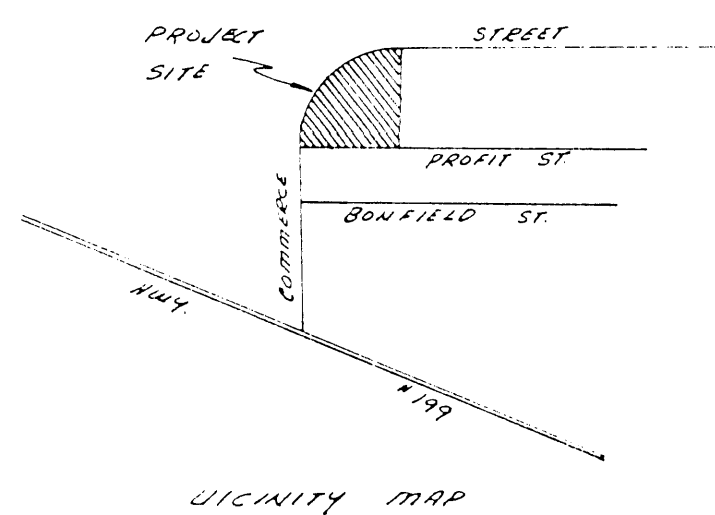

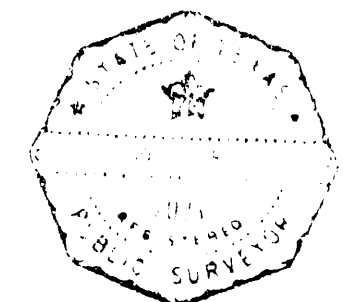
