FIELD NOTES

FIELD NOTES of a Revision of Lots 3,4,5,6,7,8,9,10 & 11 of Block 7 of the Carter's Addition to the City of Weatherford, in Parker County, Texas as recorded in Book 69, Page 639 of the Parker County Deed Records, Parker County, Texas and being more fully described by metes and bounds as follows:

BEGINNING at a steel rod, said point being the point of intersection of the NBL of Eighth Street with the WBL of Madison Street;
THENCE, with the NBL of the above mentioned Eighth Street WEST, 450.0 ft. to a steel rod for a corner;
THENCE NORTH, 150.0 ft. to a steel rod for a corner;
THENCE EAST, 450.0 ft. to a steel rod in the WBL of the above mentioned Madison Street, for a corner;
THENCE, with the WBL of said Madison Street SOUTH, 150.0 ft. to the place of beginning.

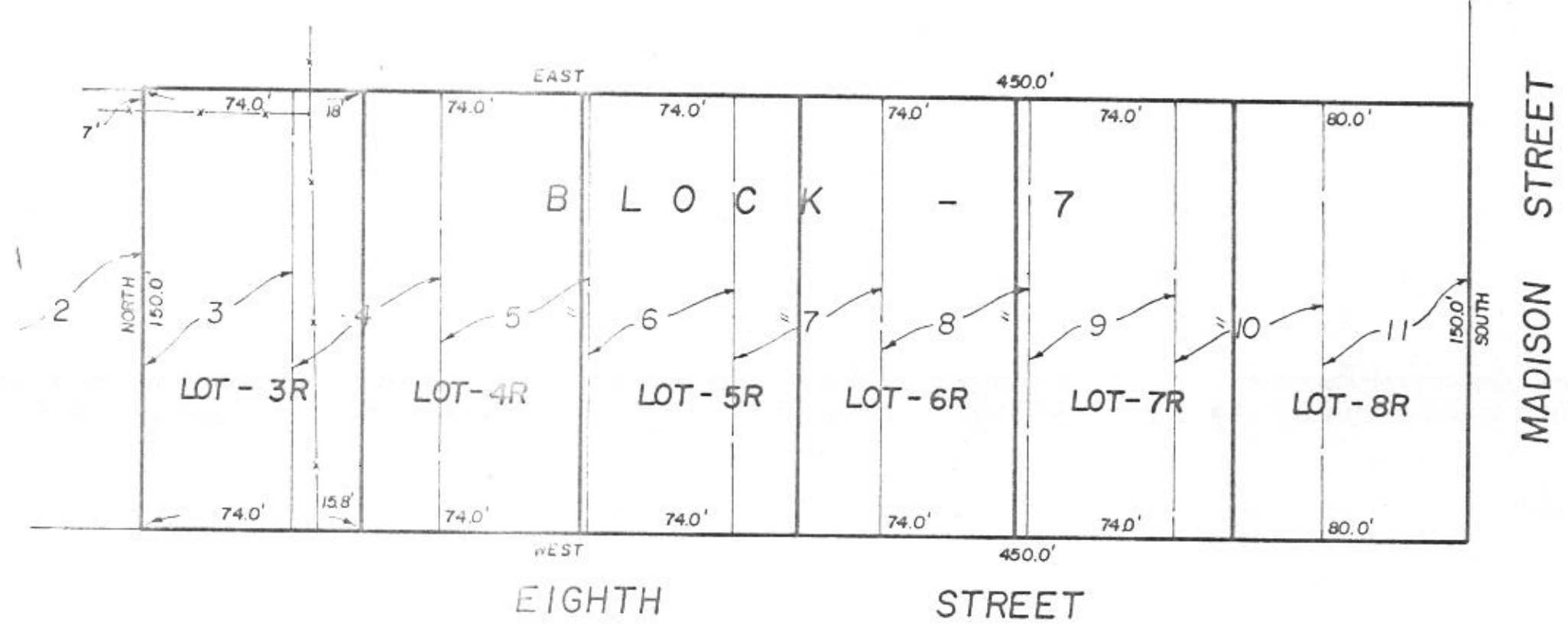
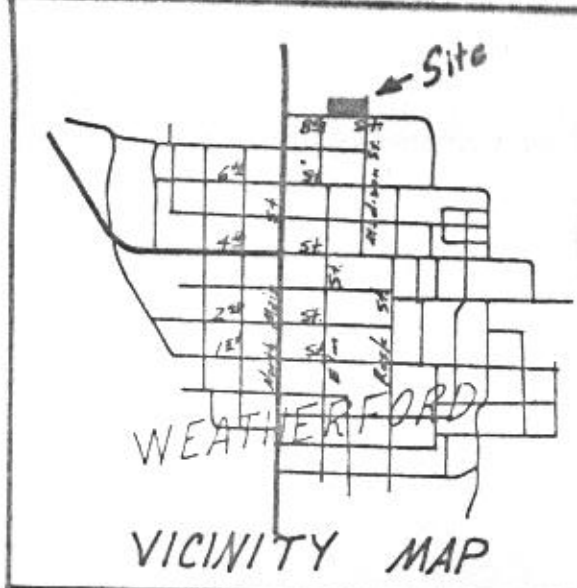
