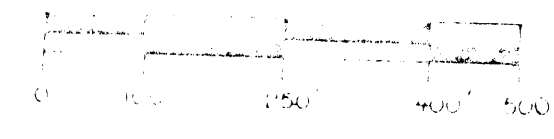
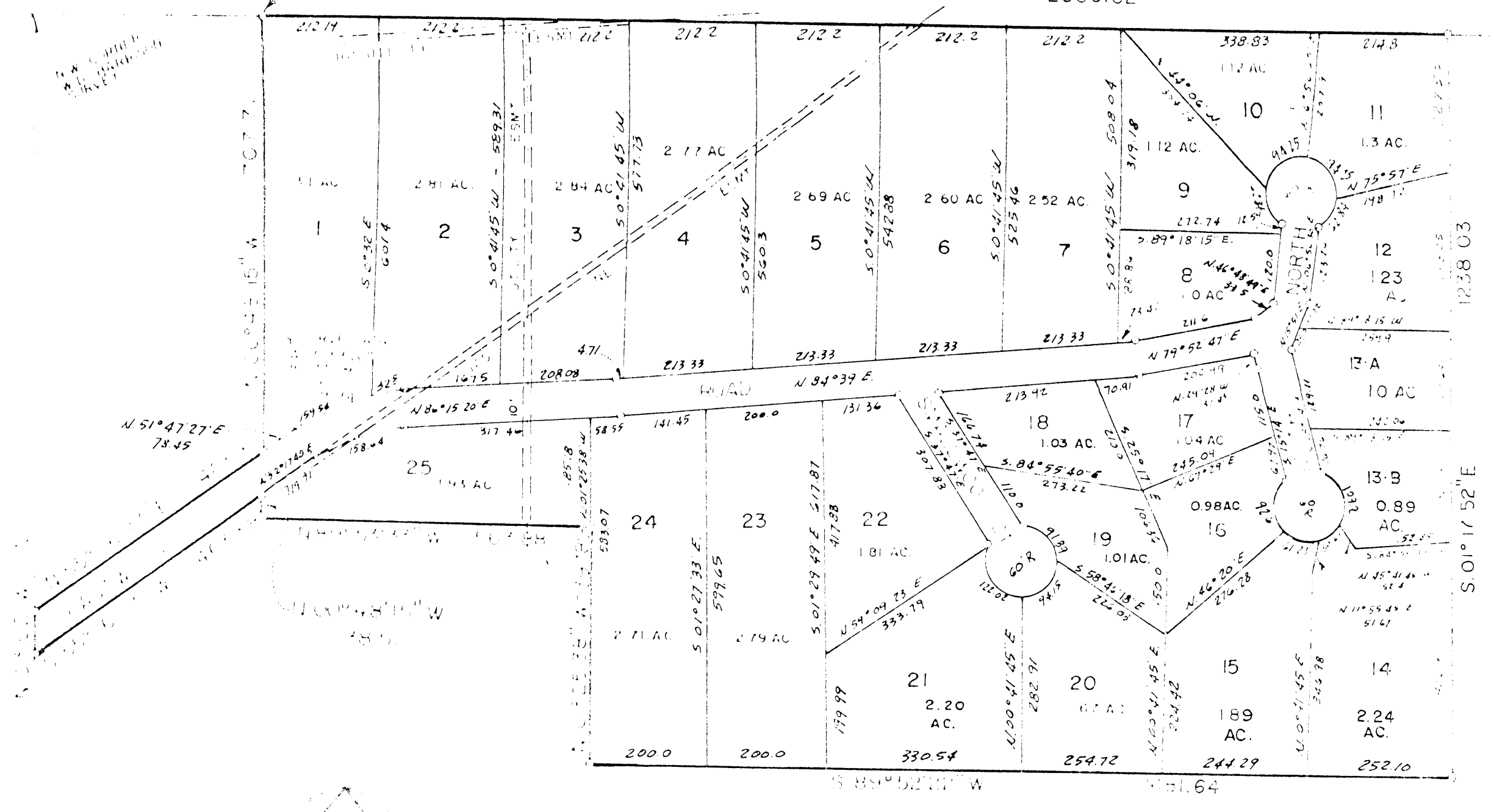

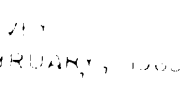

WHEREAS, W.H. SPRINGFIELD, being the owner of a tract of land out of the W.D. Harrison Survey, Patent No. 194, Volume No. 32, Abstract No. 580, Parker County, Texas, and being more fully described by metes and bounds as follows:

- Beginning at the northwest corner of said Harrison Survey; thence N. 89°20'E., 2039.02 feet to the point of beginning;
- THENCE N. 89°20'E., 2039.02 feet to a concrete monument;
- THENCE S. 01°17'52"E., 1238.03 feet to a concrete monument;
- THENCE S. 89°52'22"W., 1481.64 feet to an iron pin for a corner;
- THENCE S. 89°52'22"W., 397.89 feet to an iron pin for a corner;
- THENCE S. 89°52'22"W., 563.33 feet to an iron pin for a corner;
- THENCE S. 89°52'22"W., 35.81 feet to an iron pin for a corner;
