WHEREAS I, G.G. Ewing, being the owner of a tract of land out of the William Nix Survey Abstract No. 1021 and the John See Survey, Abstract No. 1192, Parker County, Texas as described by deed recorded in Volume 471, Page 365, Deed Records, Parker County, Texas and being being further described by metes and bounds as follows:

COMMENCING by deed call at a stone for the Northwest corner of tract 4, awarded to Minnie Prater in the partition of the lands of the Estate of Thos. P. Henderson, deceased, said corner being 1283.3 feet North and 507.5 feet West of the Southeast corner of said Nix Survey; thence South along the West line of said Tract 4, 1190 feet to a 1/2" Rebar Rod found in the East line of Arledge Street, said Rod also being the Southwest corner of a tract of land conveyed to Norman H. Belanger & wife Alicia J. Belanger by deed recorded in Volume 1493, Page 1841, Real Records, Parker County,

THENCE East, 208.53 feet along the South line of said Belanger tract to a 1/2" Rebar Rod found in the West line of Neal Hamilton Addition as recorded in Volume 324, Page 210, Plat Records, Parker County, Texas, said Rod also being the Southeast corner of the said Belanger tract;

THENCE S.00°00'47"E., 360.46 feet along the West line of said Neal Hamilton Addition to a 3/8" Rebar Rod found in the North line of Kerry Lane at the Southwest corner of said Neal Hamilton Addition;

THENCE N.64°43'55"W., 230.91 feet along the North line of said Kerry Lane to a 1/2" Rebar Rod set at the intersection of the North line of said Kerry Street and the East line of said Arledge Street;

THENCE N.00°02'41"E., 261.89 feet along the East line of said Arledge Street to the POINT OF BEGINNING and containing 1.49 Acres.

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS:

That I, G.G. Ewing, do hereby adopt this plat as Lots 1 through 5, Block 1, G. G. Ewing Addition to the City of Azle, Parker County, Texas, and do hereby dedicate to the publics use forever the streets and easements shown thereon.

That, G. G. Ewing, his successors, and assigns agree to pay for the installation and construction of all curbs, gutters and sidewalks located in the subdivision side of all streets forming a boundary of the subdivision which have not been installed at the time of the approval of this plat.
