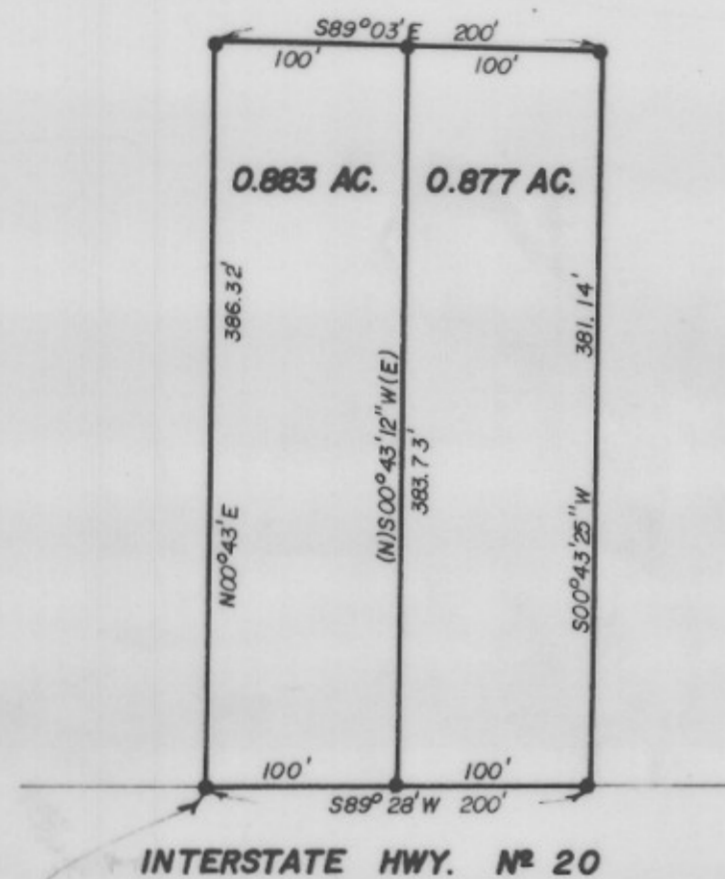

BEGINNING at a steel rod, in the NBL of Interstate Highway No. 20, said point being West 861.1 ft., N 00 deg. 45 min. E, 1069.61 ft. and N 00 deg. 49 min. E, 350.1 ft. from the SE corner of the C. A. Lovejoy Survey, Abstract 837;

THENCE N 00 deg. 43 min. E, 386.32 ft. to a steel rod for a corner;

THENCE S 89 deg. 03 min. E, 200 ft. to a steel rod for a corner;

THENCE S 00 deg. 43 min. 25 sec. W, 381.14 ft. to a steel rod, in the NBL of the above mentioned Interstate Highway No. 20, for a corner;

THENCE S 89 deg. 28 min. W, with the NBL of said Interstate Highway No. 20, 200 ft. to the place of beginning and containing 1.76 Acres of land, more or less.
