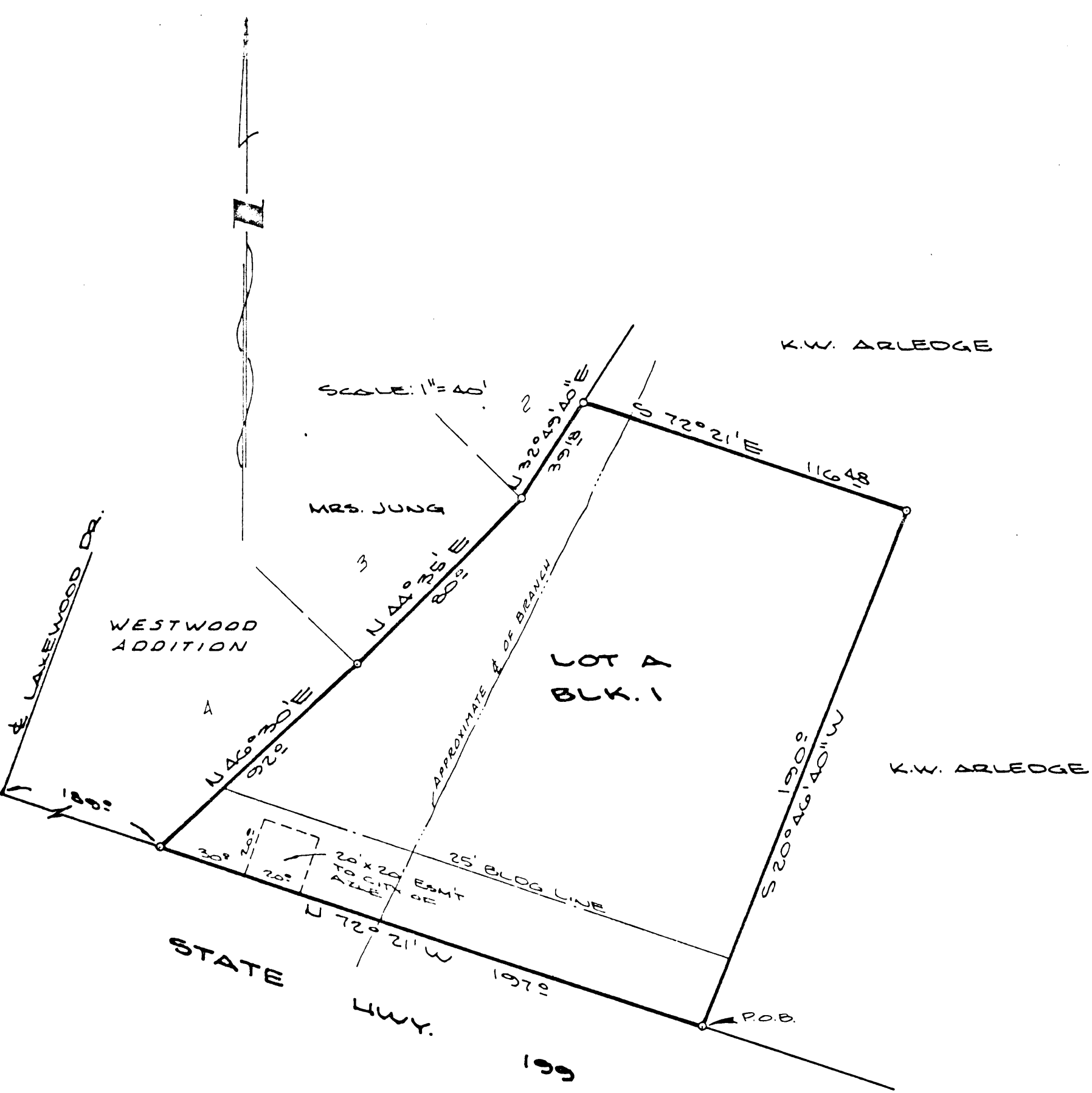

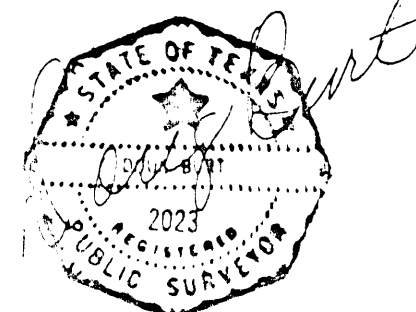


PLAT OF
