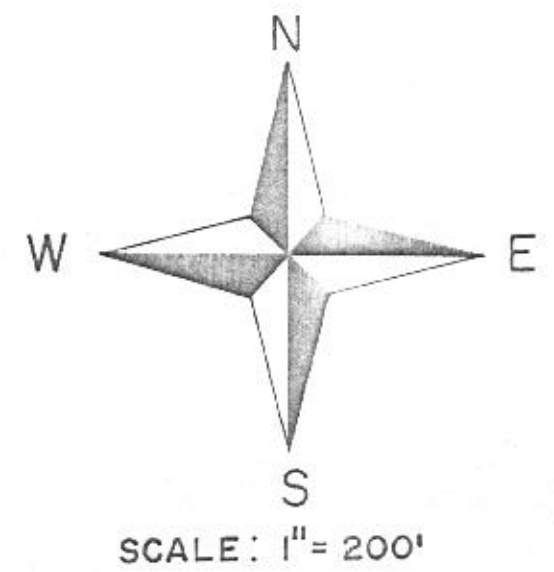


LOCATION MAP

Whereas Vernon Allison, owner, and William George, lien holder, of a tract of land out of the T. & P. RR. Co. Survey, Abstract No. 1342, Parker County, Texas, and being further more described by metes and bounds as follows;

BEGINNING at a 1/4" iron pin for corner in the north line of the Jessie Bragg Survey, Abstract No. 1713, Parker County, Texas, said iron pin being 766.79 feet N.89°18'20"W., from the most southerly southeast corner of the T. & P. RR. Co. Survey, No. 45, Abstract No. 1342, Parker County, Texas.

THENCE N.89°18'20"W., 528.41 feet to an iron pin;
 THENCE N.00°17'E., 2150.5 feet to an iron pin in the south line of a County Road;
 THENCE S.89°31'19"E., 541.8 feet along the south line of said road to an iron pin;
 THENCE S.00°38'30"W., 2152.51 feet to the point of beginning and containing 26.43 acres of land more or less.

NOW THEREFORE KNOW ALL MEN BY THE PRESENTS:

That Vernon Allison and William George do hereby adopt this plat as LA JUNTA MEADOWS, an addition to Parker County, Texas, and does hereby dedicate to the publics use forever the streets and easements shown thereon.
