THENCE S. 01° 18' E., 144.73 feet to a iron pin for a corner;
THENCE N. 89° 28' W., 210.3 feet to a iron pin for a corner in the east line of Speer Street;
THENCE N. 89° 28' W., 144.75 feet along the east line of said Speer Street to a iron pin in the north line of Speer Lane for a corner;
THENCE S. 01° 18' E., 209.47 feet along the south line of Speer Street to the point of beginning and containing 0.70 acre of land more or less.

NOW THEREFORE I KNOW ALL MEN BY THESE PRESENTS:

That Jerry W. Pozez does hereby adopt this plat as Lot 8, LEAH SEE ADDITION, an addition to the City of Azle, Parker County, Texas, and does hereby dedicate to the public use for the streets and/or easements shown thereon.

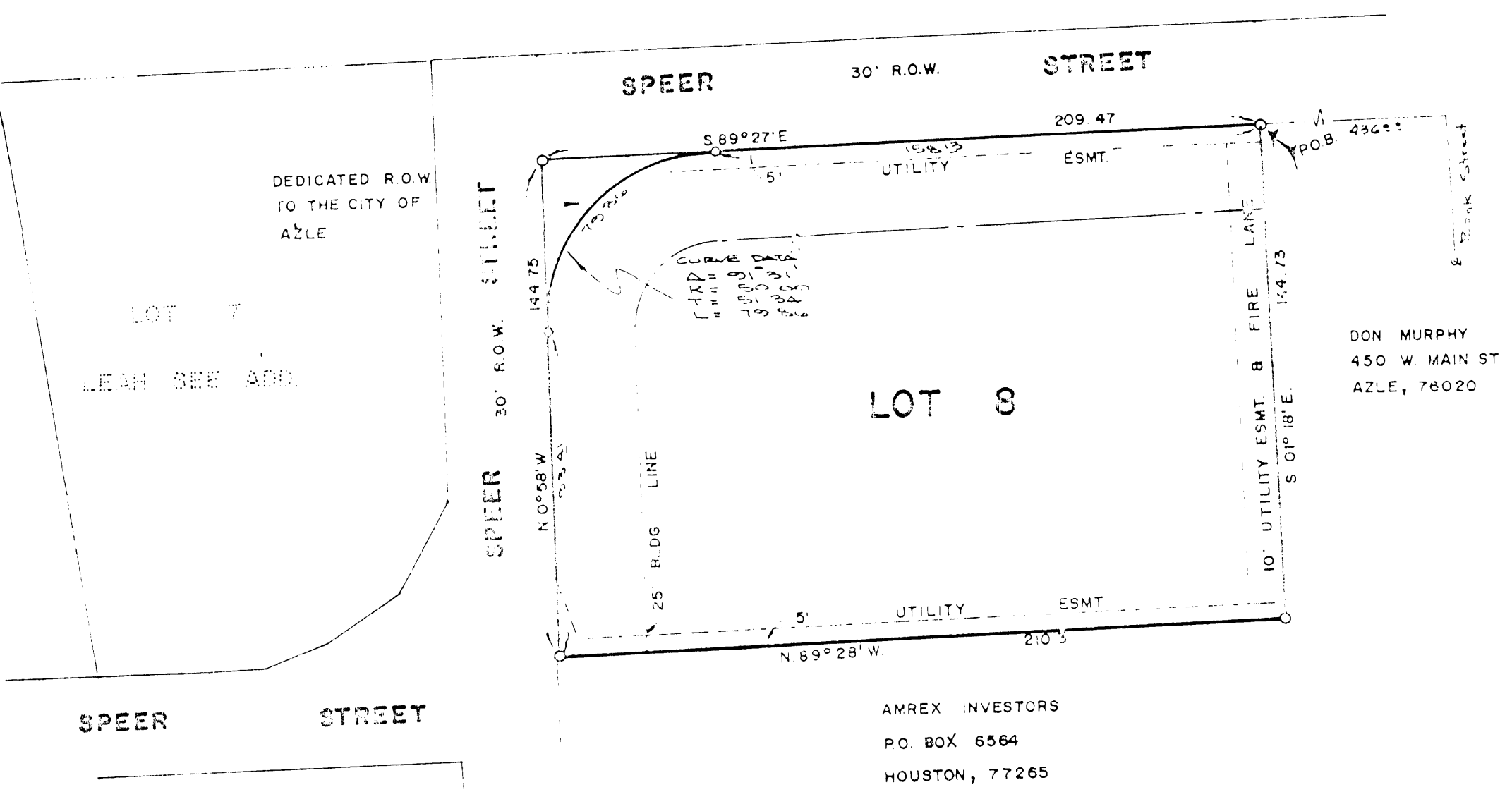

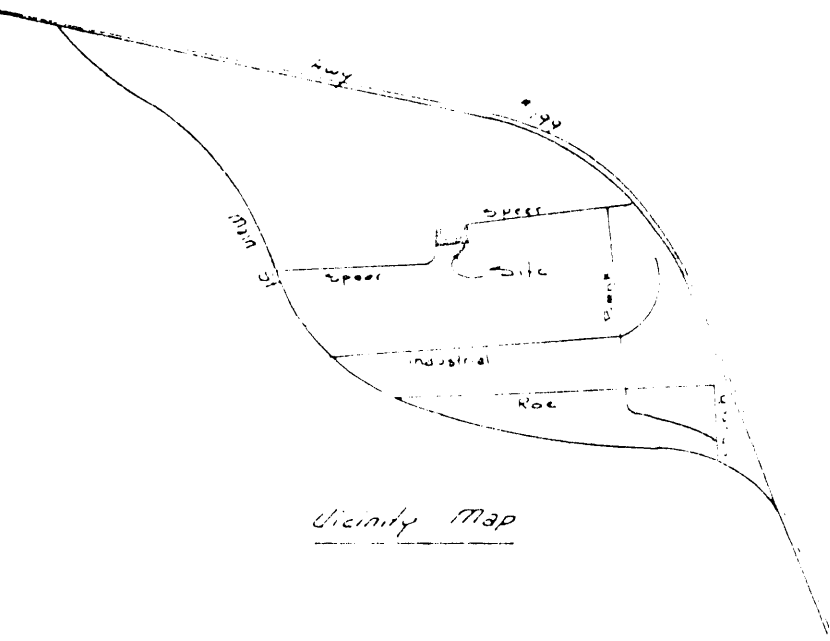

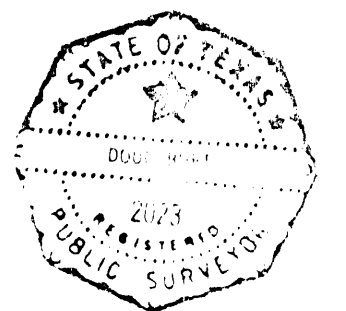
