

WE DO HEREBY WAIVER ALL CLAIMS FOR DAMAGES AGAINST THE CITY OCCASIONED BY THE ESTABLISHMENT OF GRADES OR THE ALTERATIONS OF THE SURFACE OF ANY PORTION OF THE EXISTING STREETS AND ALLEYS, OR NATURAL CONTOURS, TO CONFORM TO THE GRADES ESTABLISHED IN THE SUBDIVISION.

WHEREAS OPEN LANDS, INC., ACTING BY AND THROUGH THE UNDERSIGNED, ITS DULY AUTHORIZED OFFICER, IS THE SOLE OWNER OF A TRACT OF LAND SITUATED IN THE B.F. DRAPER SURVEY, ABSTRACT NO. 405, ACCORDING TO THE DEED RECORDED IN VOLUME 1854, PAGE 739, D.R.P.C.T., AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEING A TRACT OF LAND IN THE B.F. DRAPER SURVEY, ABSTRACT NO. 405, CITY OF WEATHERFORD, PARKER COUNTY, TEXAS, AND BEING ALL OF A CALLED 2.291 ACRE TRACT OF LAND CONVEYED FROM BRENDA G. ALLEN TO OPEN LANDS, INC. BY DEED RECORDED IN VOLUME 1854, PAGE 739, D.R.P.C.T., AND BEING A PART OF BLOCKS 1, 2, AND 3, LEVY'S ADDITION TO SEMINARY HEIGHTS ADDITION, (RECORDING DATA UNAVAILABLE), AND BEING A PART OF A CALLED FIRST, SECOND AND THIRD TRACTS AS DESCRIBED IN A DEED RECORDED IN VOLUME 1073, PAGE 967, D.R.P.C.T. ALL BEARINGS CORRELATED TO THE NORTHERNMOST NORTHWESTERLY LINE OF SAID 2.291 ACRE TRACT. (NORTH 43 DEGREES 17 MINUTES 44 SECONDS EAST)

THENCE SOUTH 62 DEGREES 30 MINUTES 28 SECONDS WEST ALONG A NORTH LINE OF SAID 2.291 ACRE TRACT, AT 98.56 FEET PASSING A 3/4" STEEL PIN FOUND BEING THE SOUTHEAST CORNER OF SAID BLOCK 3, LEVY'S ADDITION, IN ALL 115.17 FEET TO A 1/2" STEEL

THENCE NORTH 43 DEGREES 17 MINUTES 44 SECONDS EAST ALONG A NORTH LINE OF SAID 2.291 ACRE TRACT, 199.91 FEET TO THE PLACE OF BEGINNING AND CONTAINING 2.284 ACRES (99511 SQUARE FEET) OF LAND.

THAT OPEN LANDS, INC., BY AND THROUGH THE UNDERSIGNED, ITS DULY AUTHORIZED OFFICER, DOES HEREBY ADOPT THIS PLAT DESIGNATING THE HEREINABOVE DESCRIBED REAL PROPERTY AS TIN TOP SUBDIVISION OF THE CITY OF WEATHERFORD, TEXAS, AND IT DOES HEREBY DEDICATE TO THE PUBLIC'S USE THE STREETS, (ALLEY, PARKS) AND EASEMENTS SHOWN THEREON.
