


Thence S. 88° 36' E., 82.54 feet to a fence post; thence S. 01° 14' W., 311.19 feet to an iron pin; thence S. 88° 36' W., 176.53 feet to an iron pin; thence N. 01° 14' E., 350.93 feet to an iron pin; thence N. 01° 14' W., 332.23 feet to an iron pin; thence N. 01° 14' E., 567.32 feet to an iron pin; thence S. 88° 36' E., 310.97 feet to a fence post, in the West line of F.M. Road No. 710; thence S. 88° 36' E., along the West line of said Road, 1062.16 feet to a pipe; thence S. 01° 14' W., 246.70 feet to the point of beginning and containing 14.21 acres of land.
