


# How to File an Online Protest:

On the Harrison County website located at [www.isouthwestdata.com](http://www.isouthwestdata.com)

Locate the Property Search area at the top of the web page.

You may search for your property by [Property Address](#), [Legal Description](#), [Geographic ID](#), or [Property ID](#).

Enter your search criteria and click [Search](#).


SEARCH BY OWNER NAME


