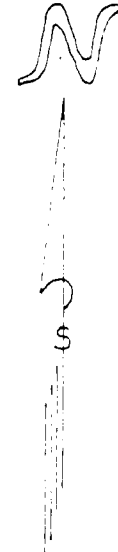
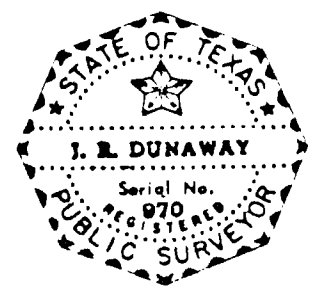


MAP SHOWING
