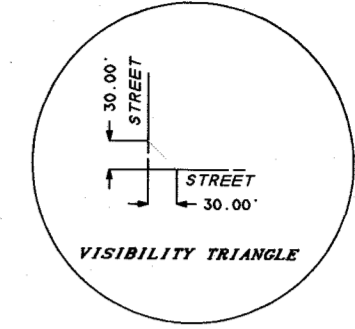
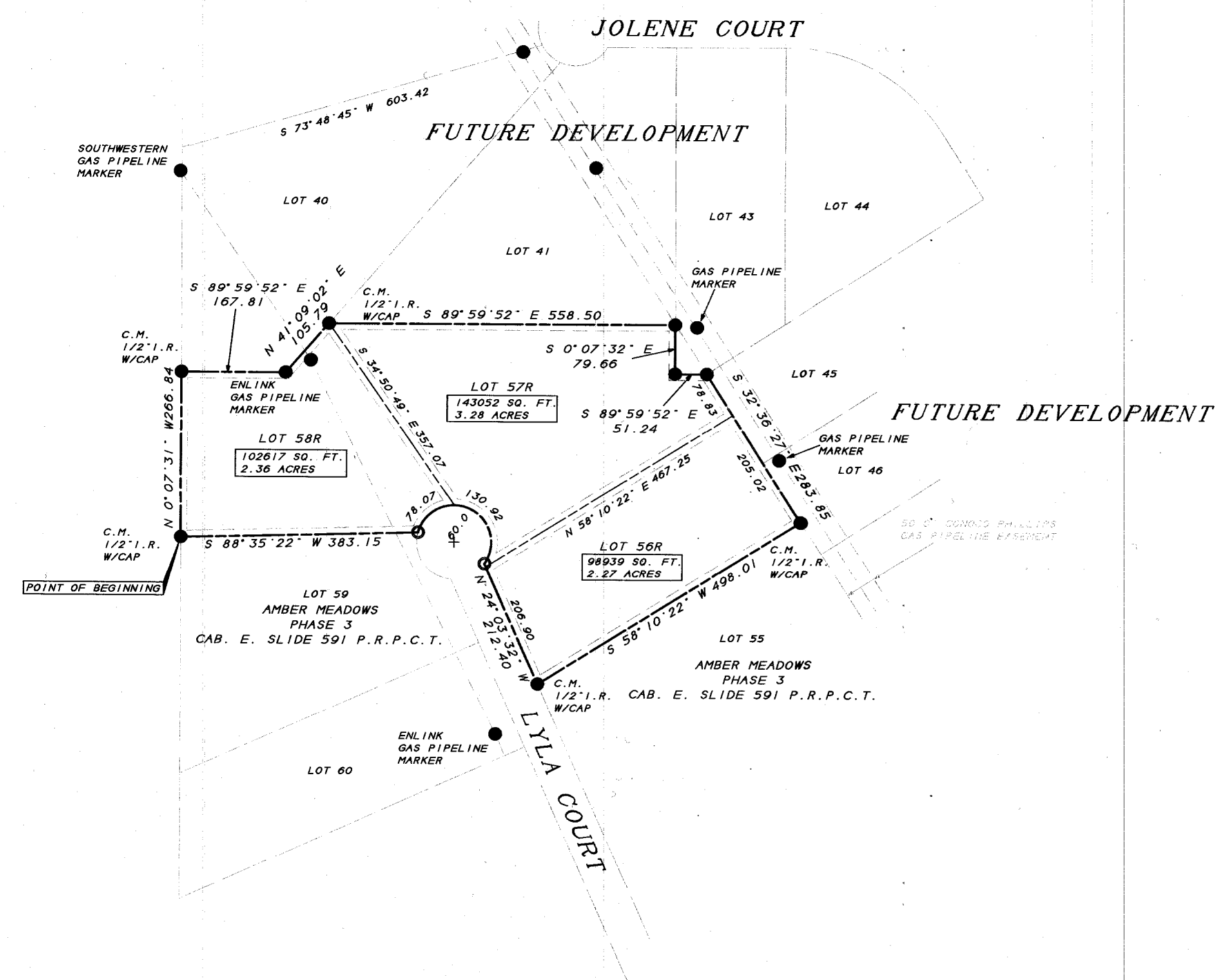


NOTE:

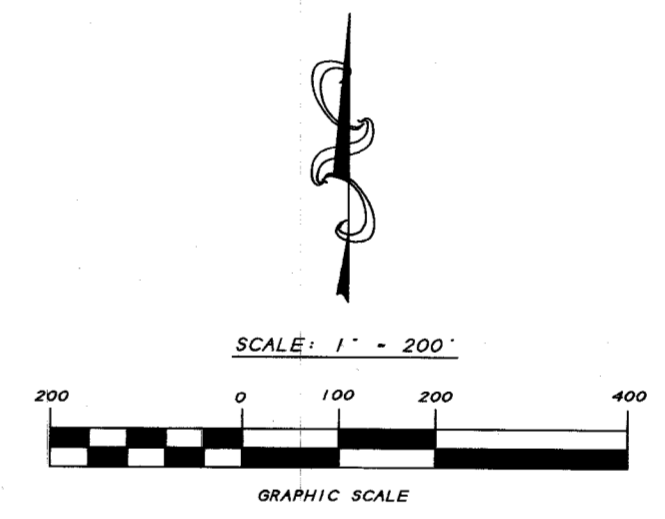
