 THENCE S 89 deg. 24 min. 20 sec. E., 125.52 ft. to a steel rod for a corner;
 THENCE N 00 deg. 26 min. 10 sec. E., 550.38 ft. to a steel rod in the SBL of U.S. Hwy No. 80, for a corner;
 THENCE, with the SBL of the above mentioned U.S Hwy No. 80 and with a Curve to the Right, said Curve having the following data: Radius 5810.69 ft.; Chord N 87 deg. 29 min. 47 sec. W., 129.82 ft. a distance of 129.83 ft. to a steel rod for a corner at the point of intersection of the SBL of said U.S. Hwy No. 80 with the EBL of above said N. Bankhead Road (Mesa St.);

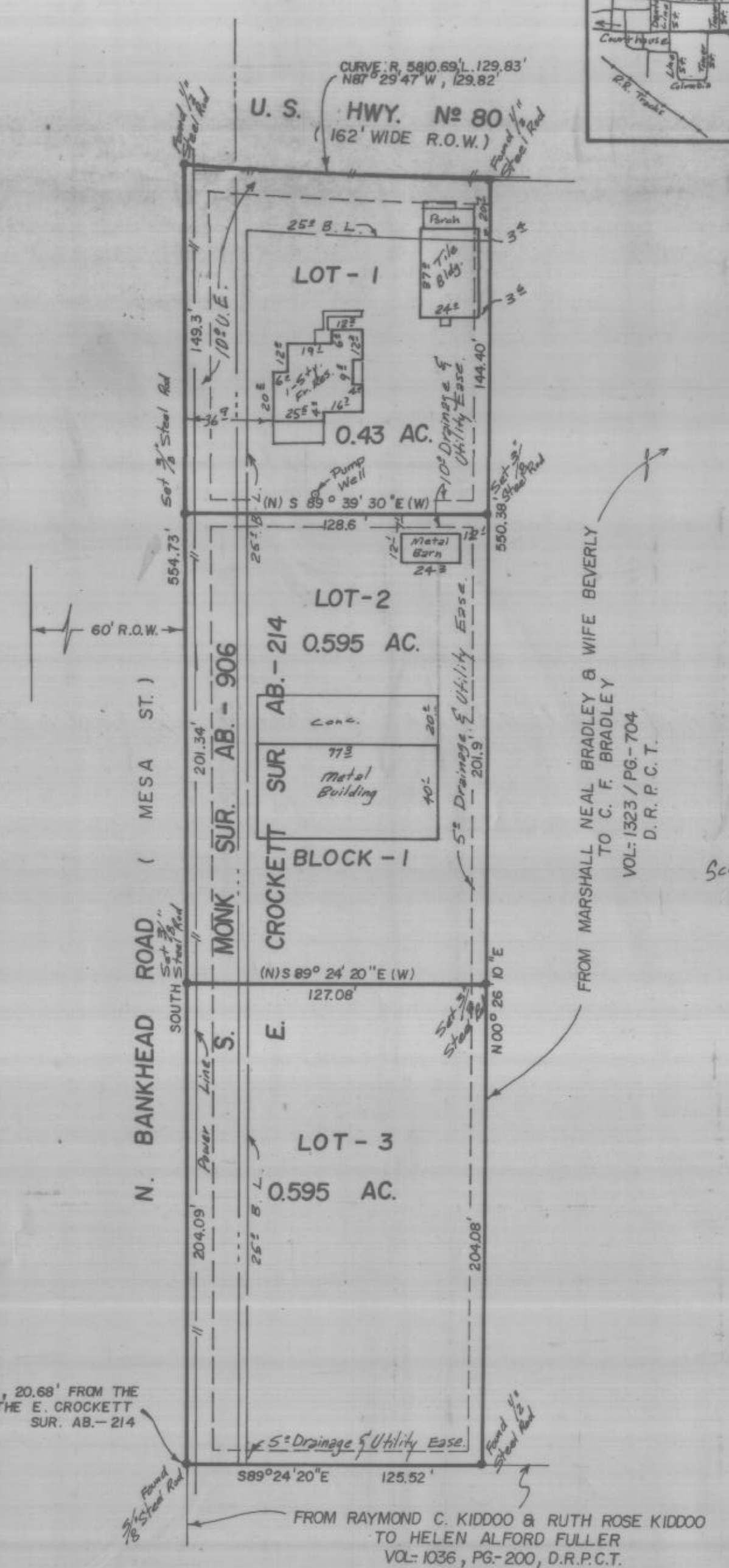
