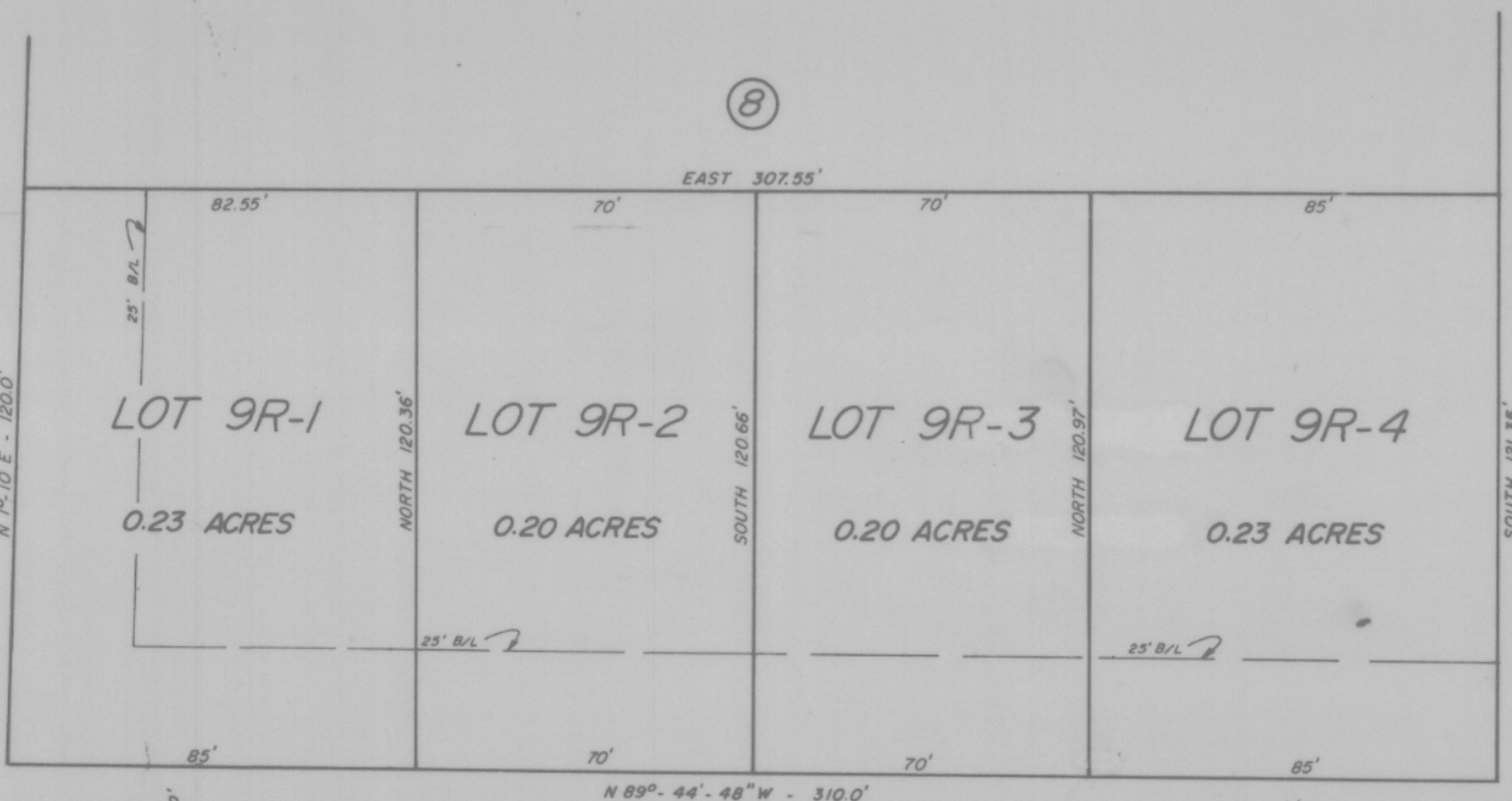




VAN WINKLE ST.

N 89° - 44' - 48" W - 310.0'

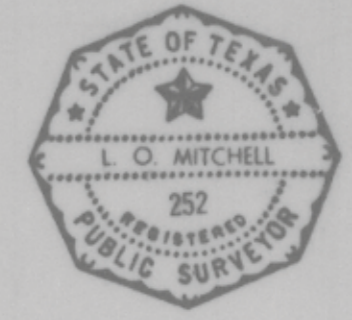
