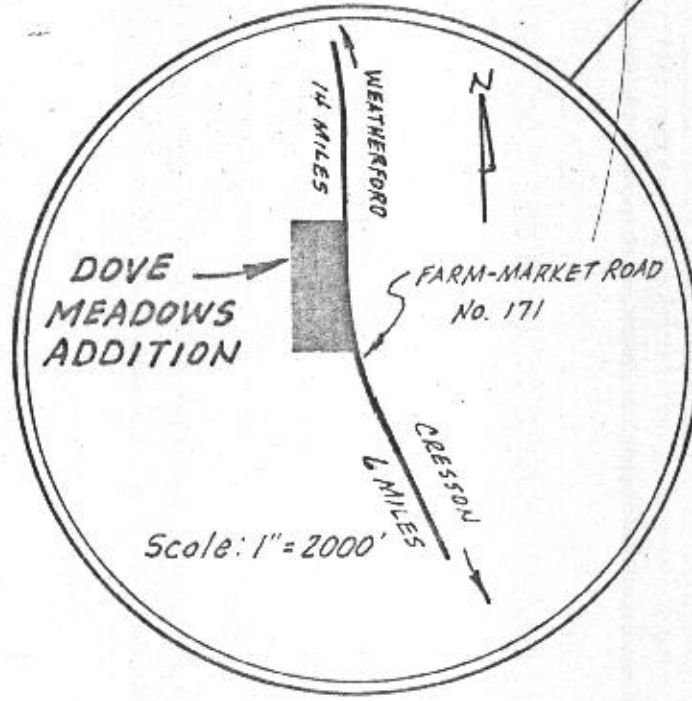

LOCATION MAP

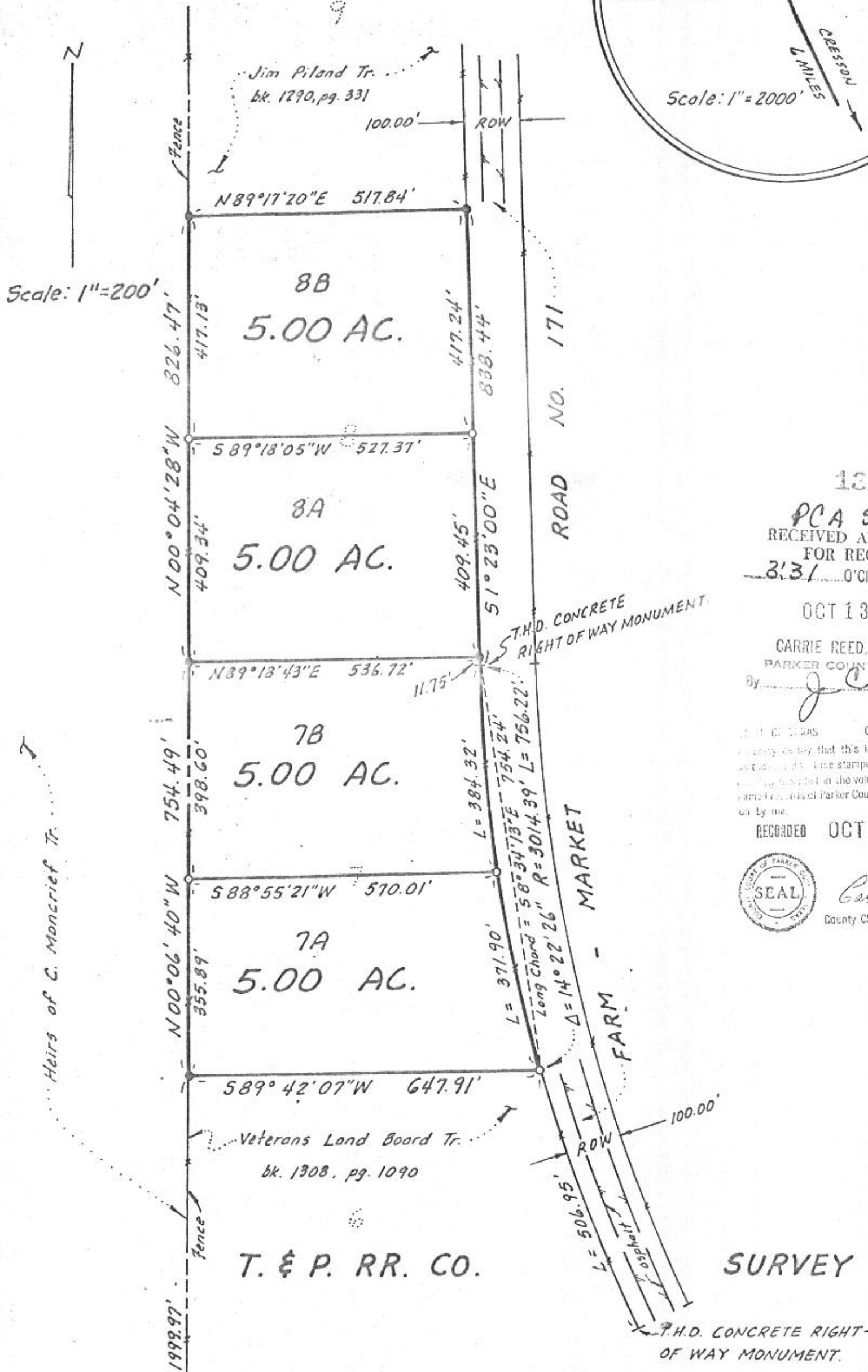
