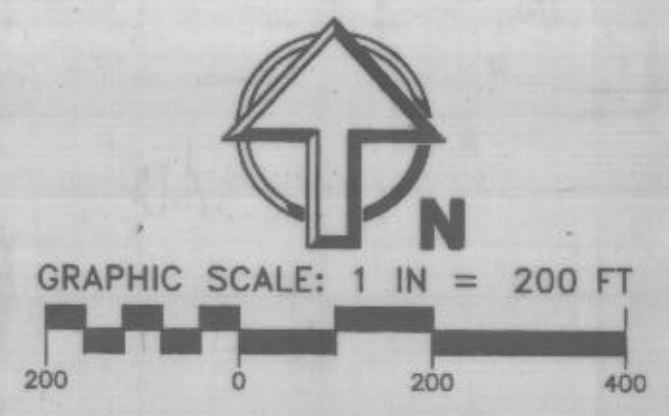
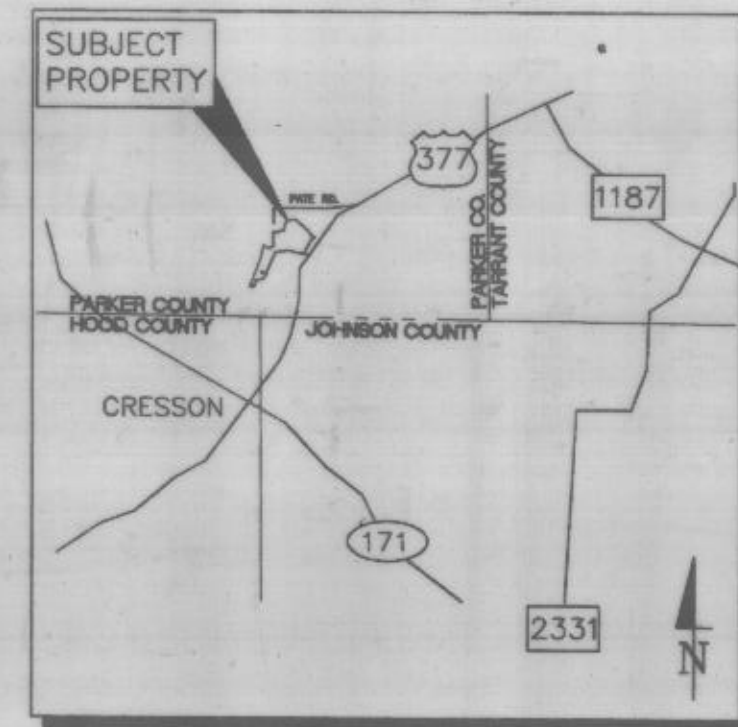


LOCATION MAP
