LEGAL DESCRIPTION

Being a 31.21 acre tract situated in the I and GN RR Company Survey, Abstract No. 1782, Parker County, Texas and being a portion of the Bear View Properties, LP tract (Bear View) as evidenced by deed recorded in Volume 2766, Page 1669, Deed Records Parker County, Texas and being more particularly described by metes and bounds as follows:

Beginning at a found 1/2 inch iron rod for the northwest corner of Lot 1R, Block B, La Madera Phase One (Phase One), an addition to Parker County as recorded in Cabinet D, Slide 224, Plat Records Parker County, Texas, said iron rod also being in the south line of Bear Country, an addition to Parker County as recorded in Cabinet C, Slide 764, Plat Records Parker County, Texas;

THENCE S 00°14'05" E, with the Bear View/Phase One common line, a distance of 347.52 feet to a found 1/2 inch iron rod for the most westerly southwest corner of Lot 2R, Block A, La Madera Phase One;

THENCE N 89°40'16" E, with the Bear View/Phase One common line, a distance of 411.63 feet to a found 1/2 inch iron rod for the beginning of a curve to the right having a radius of 570.00 feet, a central angle of 82°22'16", and a long chord bearing S 49°08'36" E, 750.69 feet;

THENCE along said curve to the right, continuing with the Bear View/Phase One common line, an arc distance of 819.46 feet to a found 1/2 inch iron rod;

THENCE S 07°57'28" E, continuing with the Bear View/Phase One common line, a distance of 226.18 feet to a found 1/2 inch iron rod for the beginning of a curve to the right having a radius of 1050.00 feet, a central angle of 8°29'01", and a long chord bearing N 85°04'02" E, 155.33 feet;

THENCE along said curve to the right, continuing with the Bear View/Phase One common line, an arc distance of 155.47 feet to a found 1/2 inch iron rod;

THENCE N 89°18'33" E, continuing with the Bear View/Phase One common line, a distance of 675.66 feet to a found 1/2 inch iron rod for the northwest corner of Lot 1, Block E, La Madera Phase Two (Phase Two), and addition to Parker County as recorded in Cabinet D, Slide 172, Plat Records Parker County, Texas;

THENCE S 11°18'56" W, with the Bear View/Phase Two common line, a distance of 552.04 feet to a found 1/2 inch iron rod for the northeast corner of that certain tract described to Mercer Real Estate Investment 1, LLC, Tract Two (Mercer Two), as recorded in Document No. 201303576 Deed Records Parker County, Texas;

THENCE S 89°18'33" W, with the Bear View/Mercer Two common line, at 609.03 feet passing a found 1/2 inch iron rod for the northwest corner of said Mercer Two tract, in all a distance of 670.76 feet to a set 1/2 inch iron rod, said iron rod being in the east line of that certain tract described to Mercer Real Estate Investment 1, LLC, Tract One (Mercer One), as recorded in Document No. 201303576 Deed Records Parker County, Texas, for the beginning of a curve to the left having a radius of 370.00 feet, a central angle of 22°56'57", and a long chord bearing N 2°29'04" E, 147.21 feet;

THENCE along said curve to the left, with the Bear View/Mercer One common line, an arc distance of 148.20 feet to a found 1/2 inch iron rod;

THENCE N 08°37'11" W, continuing with the Bear View/Mercer One common line, a distance of 385.18 feet to a found 1/2 inch iron rod for the most northerly corner of said Mercer One tract, said iron rod also being the most southerly corner of said Lot 2R, Block A, La Madera Phase One, for the beginning of a curve to the left having a radius of 1050.00 feet, a central angle of 13°17'55", and a long chord bearing S 74°10'34" W, 243.16 feet;

THENCE along said curve to the left, continuing with the Bear View/Mercer One common line, an arc distance of 243.71 feet to a found 1/2 inch iron rod;

THENCE S 67°31'37" W, continuing with the Bear View/Mercer One common line, a distance of 134.14 feet to a found 1/2 inch iron rod for the beginning of a curve to the left having a radius of 990.00 feet, a central angle of 14°47'42", and a long chord bearing S 60°07'46" W, 254.93 feet;

THENCE along said curve to the left, continuing with the Bear View/Mercer One common line, an arc distance of 255.64 feet to a set 1/2 inch iron rod;

THENCE N 25°35'00" W, leaving the Bear View/Mercer One common line, a distance of 470.47 feet to a set 1/2 inch iron rod;

THENCE S 89°45'55" W a distance of 387.51 feet to a set 1/2 inch iron rod;

THENCE N 45°59'51" W a distance of 286.46 feet to a set 1/2 inch iron rod;

THENCE N 00°14'05" W a distance of 681.46 feet to a set 1/2 inch iron rod, said iron rod being in the south line of said Bear Country;

THENCE N 89°45'18" E, with the Bear View/Bear Country common line, a distance of 366.34 feet to the Point of Beginning and Containing 1,359,295 square feet, 31.21 acres of land, more or less.

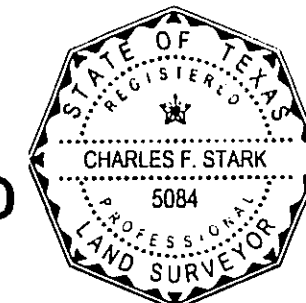
