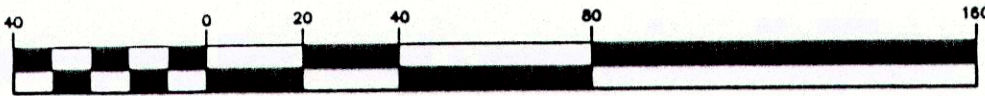


NORTH GRAPHIC SCALE

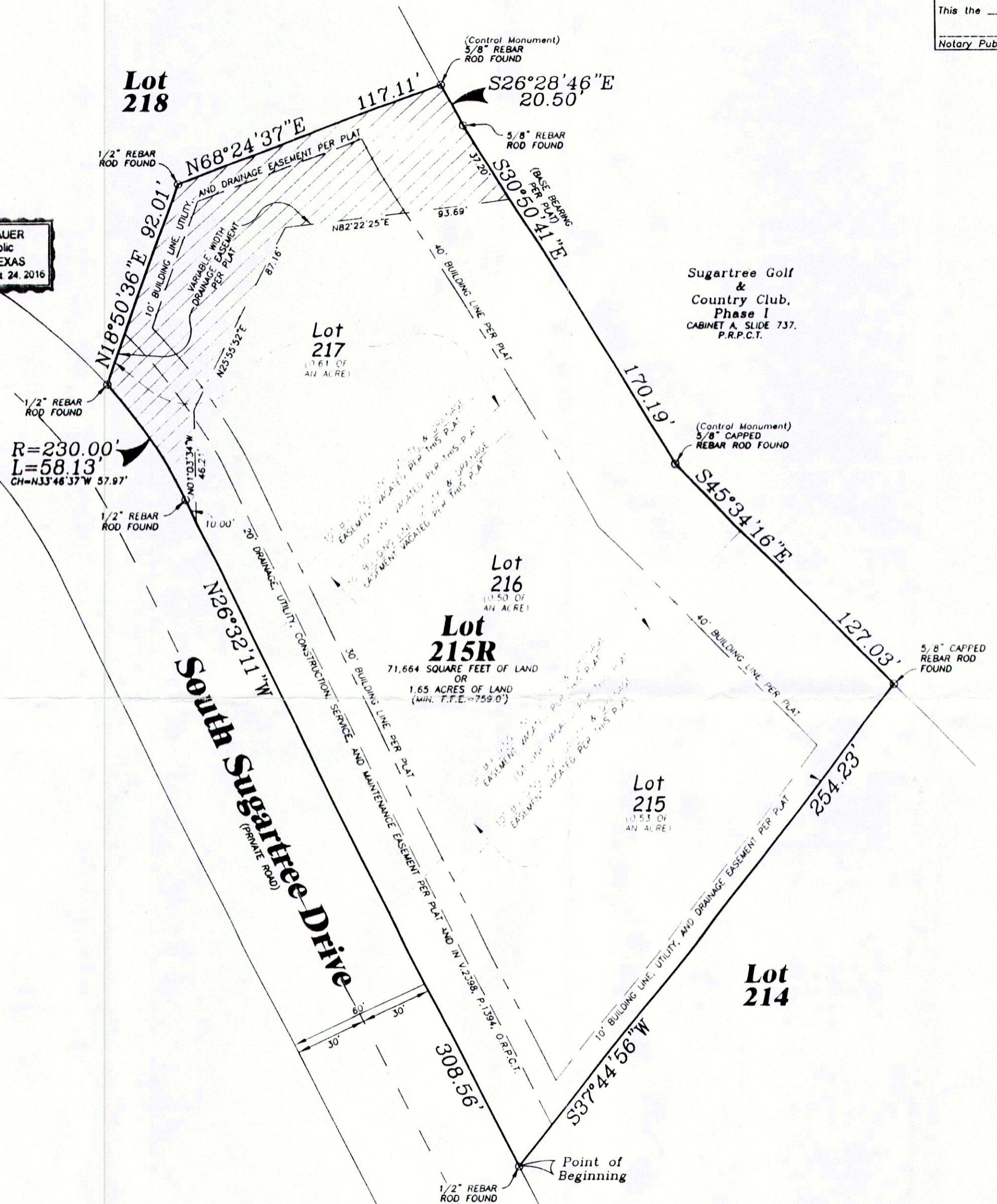
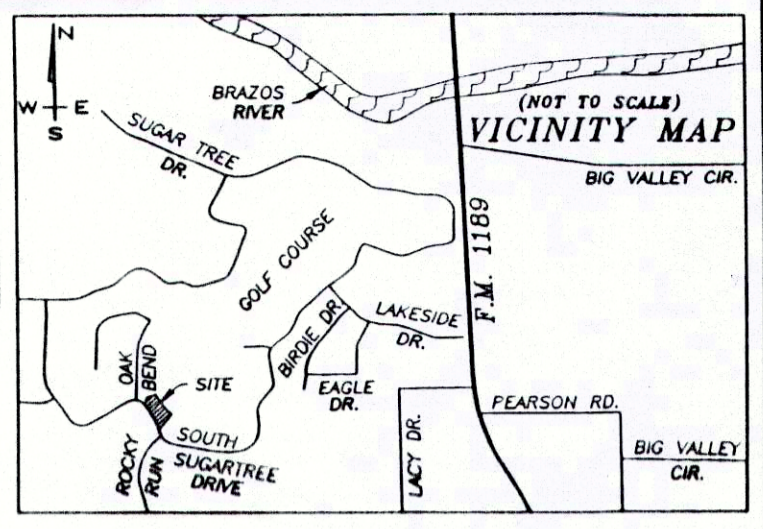

WHEREAS We, Rick L. Bolte and Aymie M. Bolte, being the owners of 1.65 acres of land being Lots 215, 216, and 217, Sugartree on the Brazos, Phase Three, an addition in Parker County, Texas, according to the plat thereof recorded in Cabinet C, Slide 491, Plat Records, Parker County, Texas, and being more particularly described in a deed recorded in Document Number 201417057, Official Records, Parker County, Texas, being more particularly described by metes and bounds as follows:

BEGINNING at a 1/2" rebar rod found in the northeast line of South Sugartree Drive, an existing 60 feet wide right of way, for the most southerly corner of Lot 215, same being the westerly corner of Lot 214;
Thence N26°32'11"W., 308.56 feet along the northeast line of said South Sugartree Drive to a 1/2" rebar rod found for the P.C. of Lot 217;
Thence along a curve to the left, with a radius of 230.00 feet, and whose chord is N33°46'37"W 57.97 feet, an arc distance of 58.13 feet along the northeast line of said South Sugartree Drive to a 1/2" rebar rod found for the westerly corner of said Lot 217, same being the southerly corner of Lot 218;
Thence N18°50'36"E., 92.01 feet along a common line of said Lot 217 and said Lot 218 to a 1/2" rebar rod found;
Thence N68°24'37"E., 117.11 feet along a common line of said Lot 217 and said Lot 218 to a 5/8" rebar rod found (Control Monument) for the northerly corner of said Lot 217, same being the easterly corner of said Lot 218, and being in a westerly line of Sugartree Golf & Country Club, Phase I, recorded in Cabinet A, Slide 737, Plat Records, Parker County, Texas;
Thence S26°28'46"E., 20.50 feet along a common line of said Lot 217, and said Sugartree Golf & Country Club to a 5/8" rebar rod found;
Thence S30°50'41"E. (BASE BEARING PER PLAT), 170.19 feet along a common line of said Lot 217; said Lot 216, and said Sugartree Golf & Country Club to a 5/8" capped rebar rod found (Control Monument);
Thence S45°34'16"E., 127.03 feet along a common line of said Lot 216; said Lot 215, and said Sugartree Golf & Country Club to a 5/8" capped rebar rod found for the easterly corner of said Lot 215, same being the most northerly corner of said Lot 214;
Thence S37°44'56"W., 254.23 feet along a common line of said Lot 215 and said Lot 214 to the point of beginning and containing 1.65 acres of land more or less.

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS That We, Rick L. Bolte and Aymie M. Bolte, do hereby adopt this plat designating the herein described real property as Lot 215R, Sugartree on the Brazos, Phase Three, an addition in Parker County, Texas, and do hereby dedicate to the public's use forever the easements and streets shown hereon.
