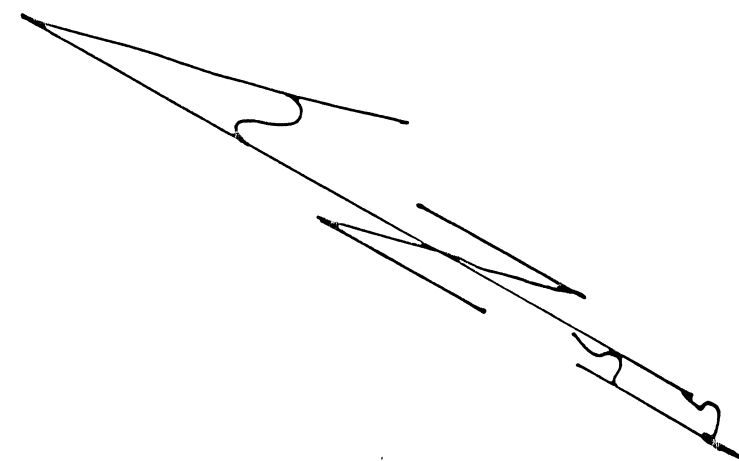

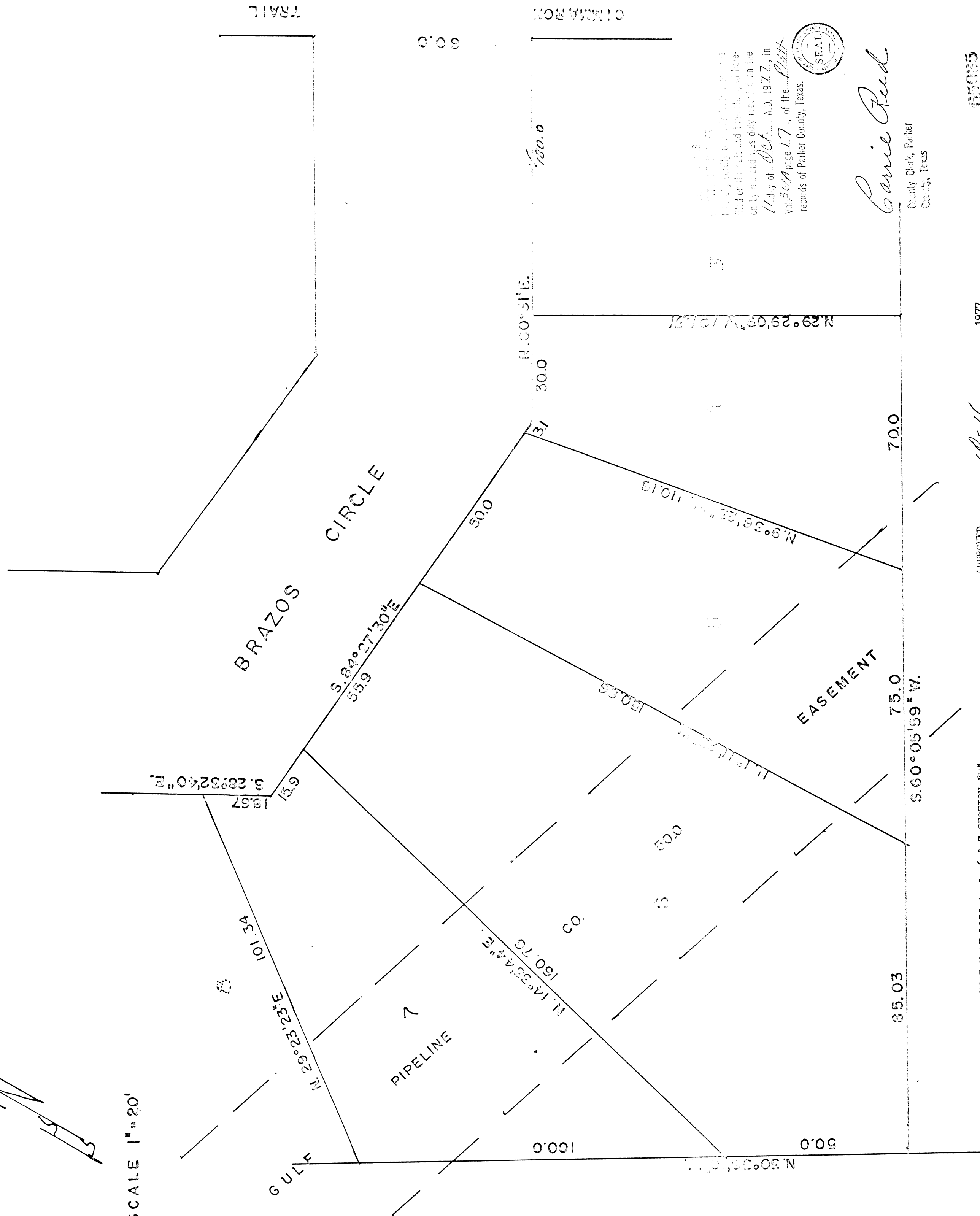
Utility easements are reserved along and within 5 feet of all boundaries of all lots shown on this plat.

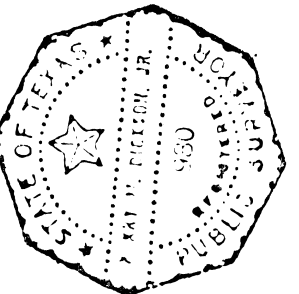
