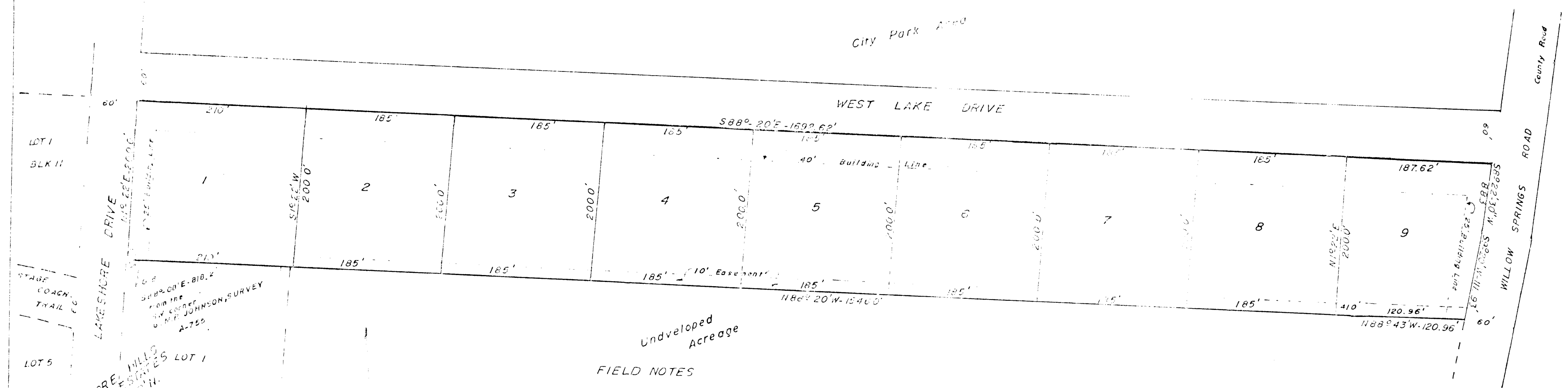


WESTHAVEN

 FIELD NOTES

BEING all that certain tract or parcel of land a part of the G.M.P. JOHNSON, SURVEY, Abstract No. 755, in Parker County, Texas, and more fully described as follows:
 BEGINNING at an iron pin in the EBL of Lakeshore Drive, S88°08'E, 618.2', from the 1st corner of G.M.P. JOHNSON, Survey;
 THENCE, N19°22'E, 2000', iron pin corner in SBL, WEST LAKE DR.;
 THENCE, with the SBL of WEST LAKE DR. S88°20'E-1692.62', iron corner in WBL of a county road;
 THENCE, with the WBL of a county road, S89°22'-30'W, 668.3 ft.; S9° 20' W, 111.93 ft. iron pin corner;
 THENCE, N88°43'W, 120.96 ft.; N88°20'W, 1546.0 ft. to the Point of Beginning, and containing 7.71 acres of land.

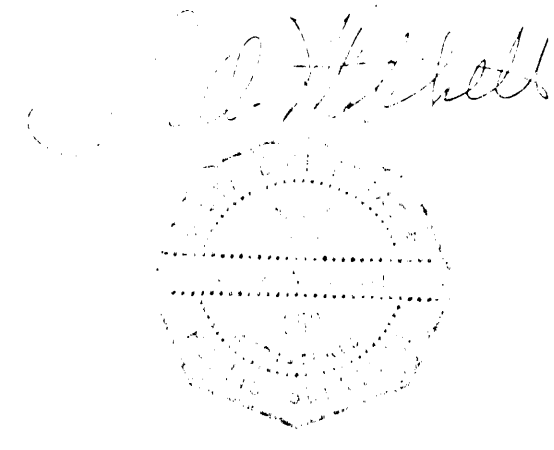
