DEDICATION

WHEREAS, William E. Shields Jr., Dorothy M. Staterfield, Carl Ingram Estate, and Azle State Bank, being the owners of a tract of land out of the Leah Lee Survey, Abstract No. 2017, Tarrant County, and Abstract No. 805, Parker County, Texas, and being more fully described by metes and bounds as follows;

Beginning with an iron pin at the intersection of the east line of Main St. and the north line of Locust St., said iron pin also being the most southerly corner of Lot 1, Block 1, Wayne Dunaway's Addition as shown on the plat recorded in vol. 388-F, pg. 269, Plat Records, Tarrant County, Texas.

Then along S 89°34'E, 290.73 feet along the east line of Main St. to an iron pin for a corner;

Then along N 89°28'E, 192.68 feet to an iron pin for a corner;

Then along S 89°04'45"W, 192.68 feet to an iron pin in the west line of Bank St.

Then along S 89°04'45"W, 294.52 feet along the west line of Bank St. to a corner;

Then along S 89°04'45"W, 294.52 feet along the west line of Bank St. to a corner;

Then along S 89°04'45"W, 116.11 feet along the north line of Locust St. to an iron pin for a corner;

Then along S 89°04'45"W, 69.80 feet along the north line of Locust St. to an iron pin for a corner;

Then along S 89°04'45"W, 128.17 feet along the north line of Locust St. to an iron pin for a corner;

Then along S 89°04'45"W, 71.65 feet along the north line of Locust St. to the point of beginning and containing 2.4 acres of land more or less.

NOW THEREFORE, BEING ALL MEN BY THESE PRESENTS:

That the City of Azle, Texas, does hereby adopt this plat as ASH CREEK STORAGE ADDITION, an addition to the City of Azle, in both Tarrant and Parker Counties, and does hereby dedicate to the public's use the streets and easements shown thereon.

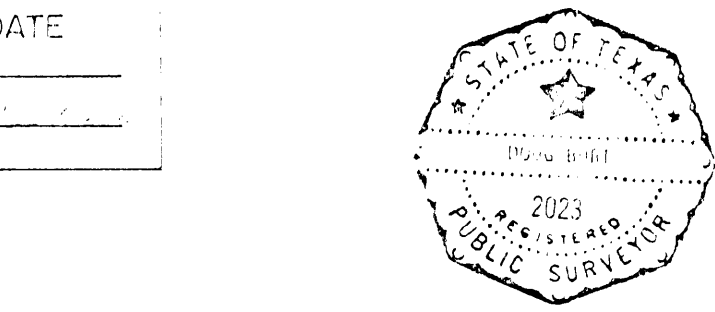

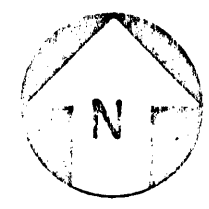

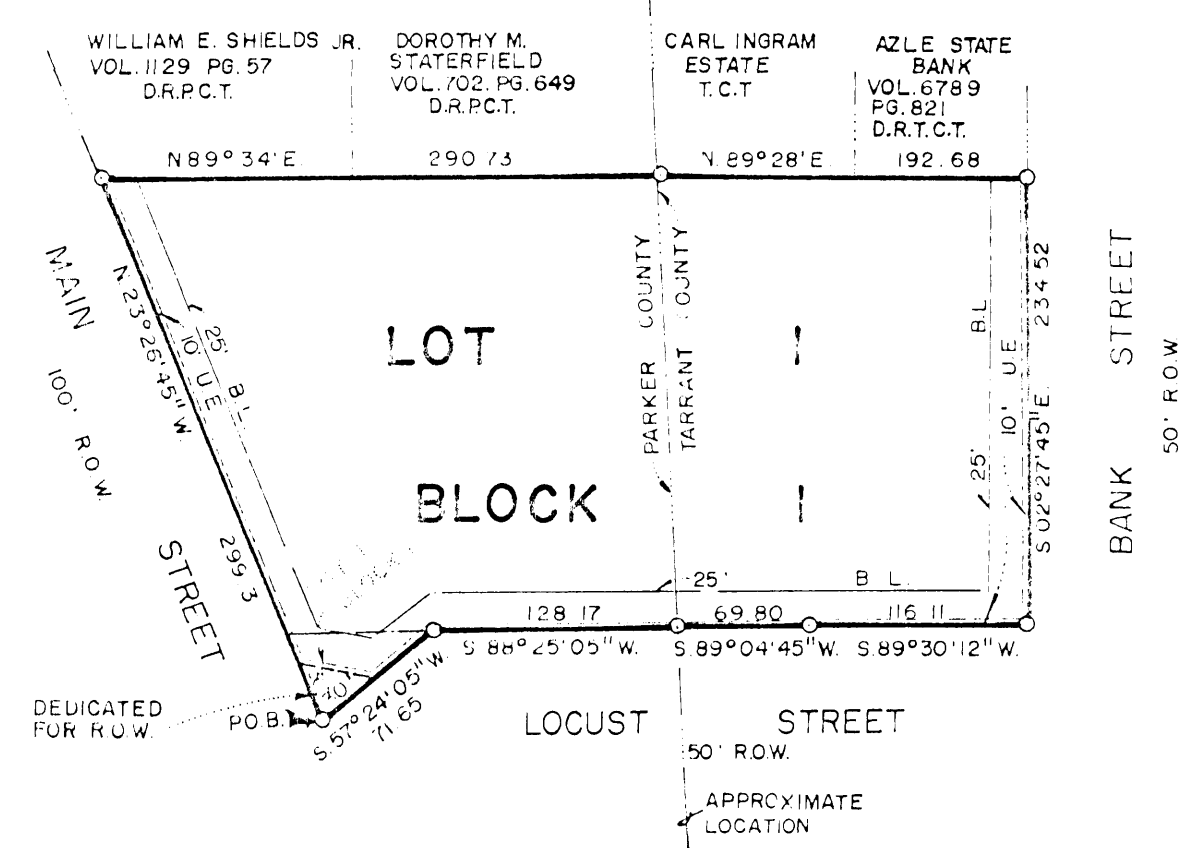

 SURVEYED ON THE GROUND JANUARY, 15, 1985

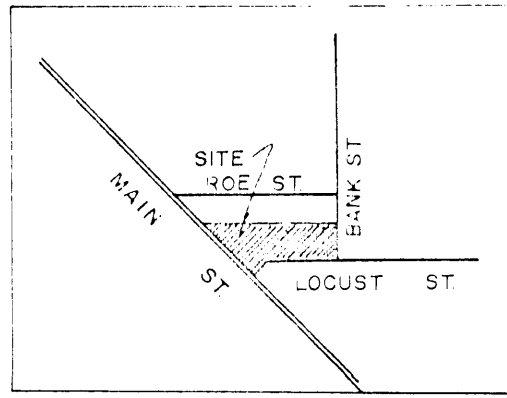


GRAPHIC SCALE
