S.  $60^{\circ}$  - 16' - 28'' E. 434.52 feet to an iron pin in the Westerly line of a road easement, said point being in the line of a cul de ale having a radius of 50.0 feet;

Southeasterly with the arc of said cul de sac 166.37 feet to an iron THENCE oth for corner;

S.  $85^{\circ}$  - 37' - 05'' E. 74.26 feet continuing along the South line of said road easement to an iron pin in same for corner;
