W, 792.87 ft. to @ found 1/2" steel rod for a corner; THENCE N 01 deg. 05 min. 11 sec. E, 723.15 ft. to a set 1/2" steel rod for a corner; THENCE \$ 88 deg. 50 min. 43 sec. E, 742.09 ft. to a set 1/2" steel rod for a corner; THENCE N 00 deg. 15 min. 13 sec. E. 1595.07 ft. to a found 1/2" steel rod in the SBL of Interstate Highway 20, for a corner; THENCE with the SBL of the above mentioned highway and with a Curve to the Right, said curve having the following datum: Radius 5554.38 ft., Chord N 83 deg. 51 min. 44 sec. E, 60.35 ft., a distance of 60.35 ft. to a found 1/2" steel rod for a corner; THENCE s 00 deg. 15 min. 13 sec. W, 2058.36 ft. to a set 1/2" steel rod for a corner; said point being the PC of a Curve to the Right; THENCE with the above mentioned Curve to the Right, said curve having the following datum: Radius 60.0 ft., Chord S 10 deg. 39 min. 53 sec. W, 113.05 ft., a distance of 147.47 ft. to a set 1/2" steel rod for a corner; THENCE South, 156.11 ft. to the point of beginning and containing 15.58 acres of land, more or less.


