

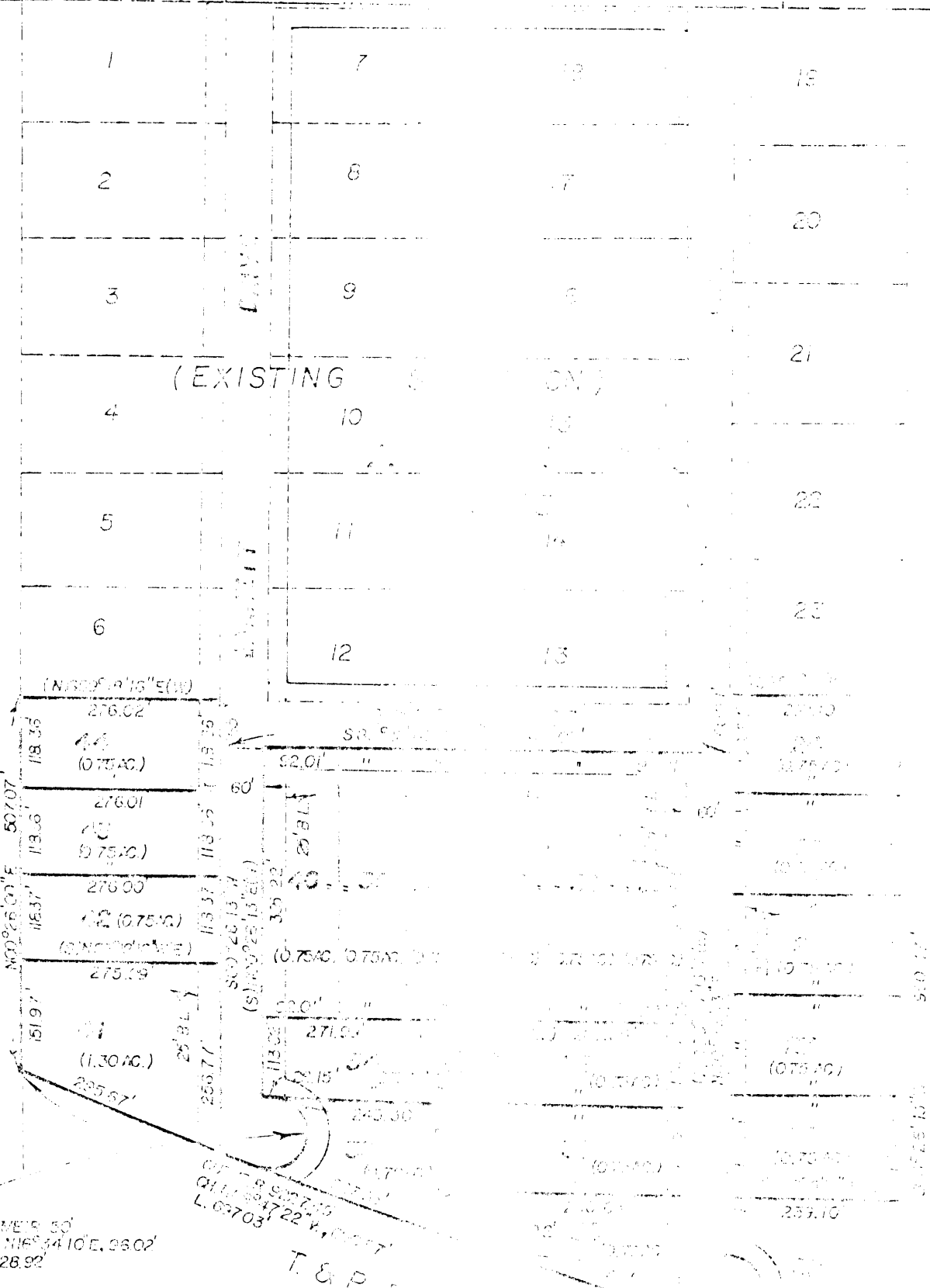

BEGINNING at a steel rod, said point being N 0 deg. 26 min. 13 sec. E, 946.86 ft. from the NW corner of the A. Moore Survey, Abstract 905;

THENCE S 89 deg. 18 min. 16 sec. E, 276.02 ft. to a steel rod, in the WBL of Barnett Drive, for a corner;

THENCE S 00 deg. 26 min. 13 sec. W, with the WBL of the above mentioned Barnett Drive, 65 ft. to a steel rod, at the intersection of the WBL of said Barnett Drive, with the SBL of Brim Street, for a corner;

THENCE S 89 deg. 18 min. 16 sec. E, with the SBL of the above mentioned Brim Street, 672.05 ft. to a steel rod, at the intersection of the SBL of said Brim Street, with the SBL of Bank Drive, for a corner;

THENCE N 00 deg. 26 min. 13 sec. E, with the EBL of the above mentioned Bank Drive, 100.91 ft. to a steel rod for a corner;

THENCE N 89 deg. 18 min. 16 sec. E, 239.10 ft. to a steel rod for a corner;

THENCE S 00 deg. 26 min. 13 sec. W, 250.47 ft. to a steel rod for a corner;

THENCE N 71 deg. 07 min. 41 sec. W, 360.08 ft. to the PC of a Curve to the Left, said Curve having the following data: Radius 9227.49 ft., Chord N 69 deg. 47 min. 22 sec. W, 698.47 ft.;

THENCE, with the above mentioned Curve to the Left, a distance of 497.03 ft. to a steel rod for a corner;
