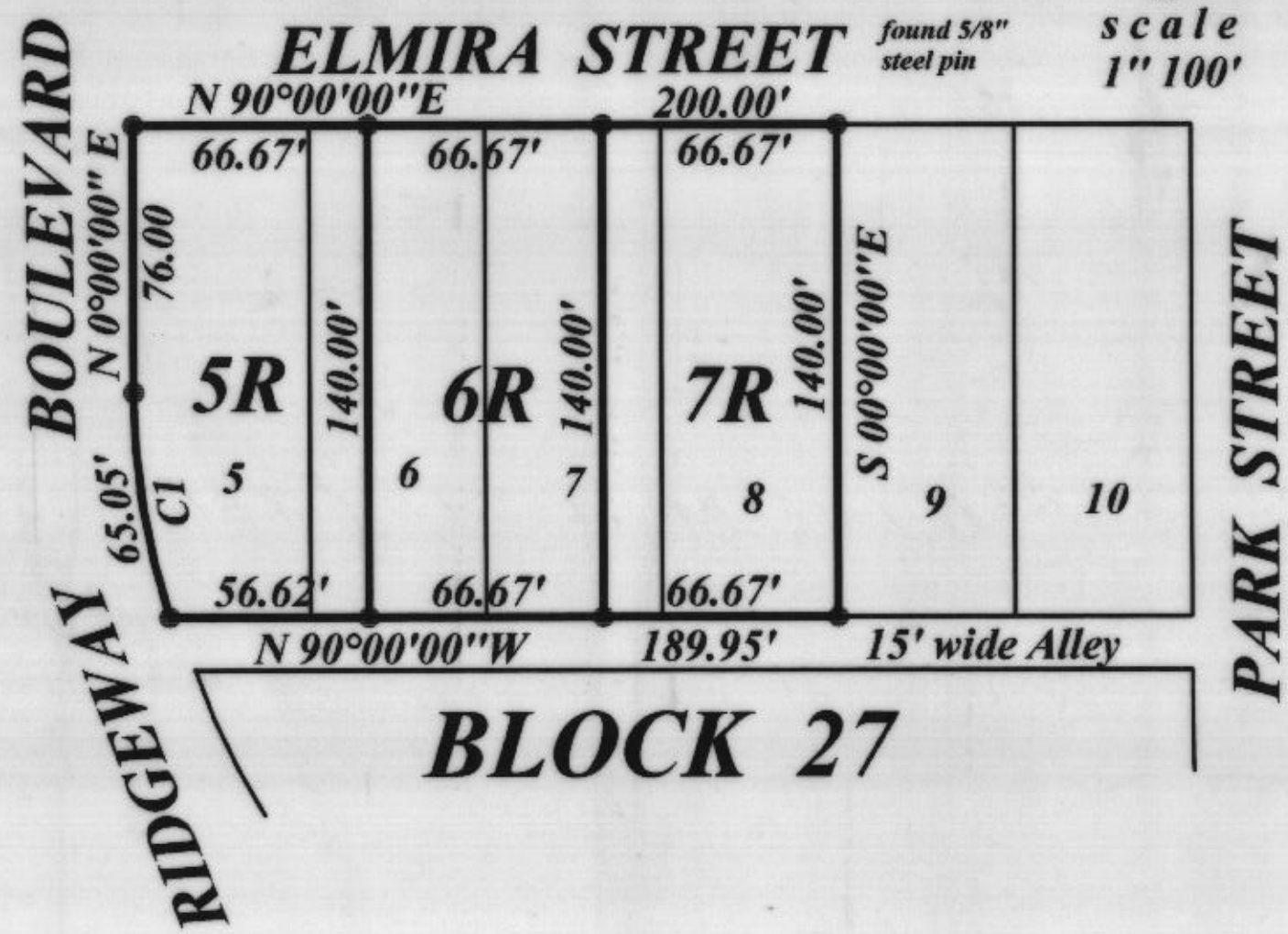


CURVE CHART
