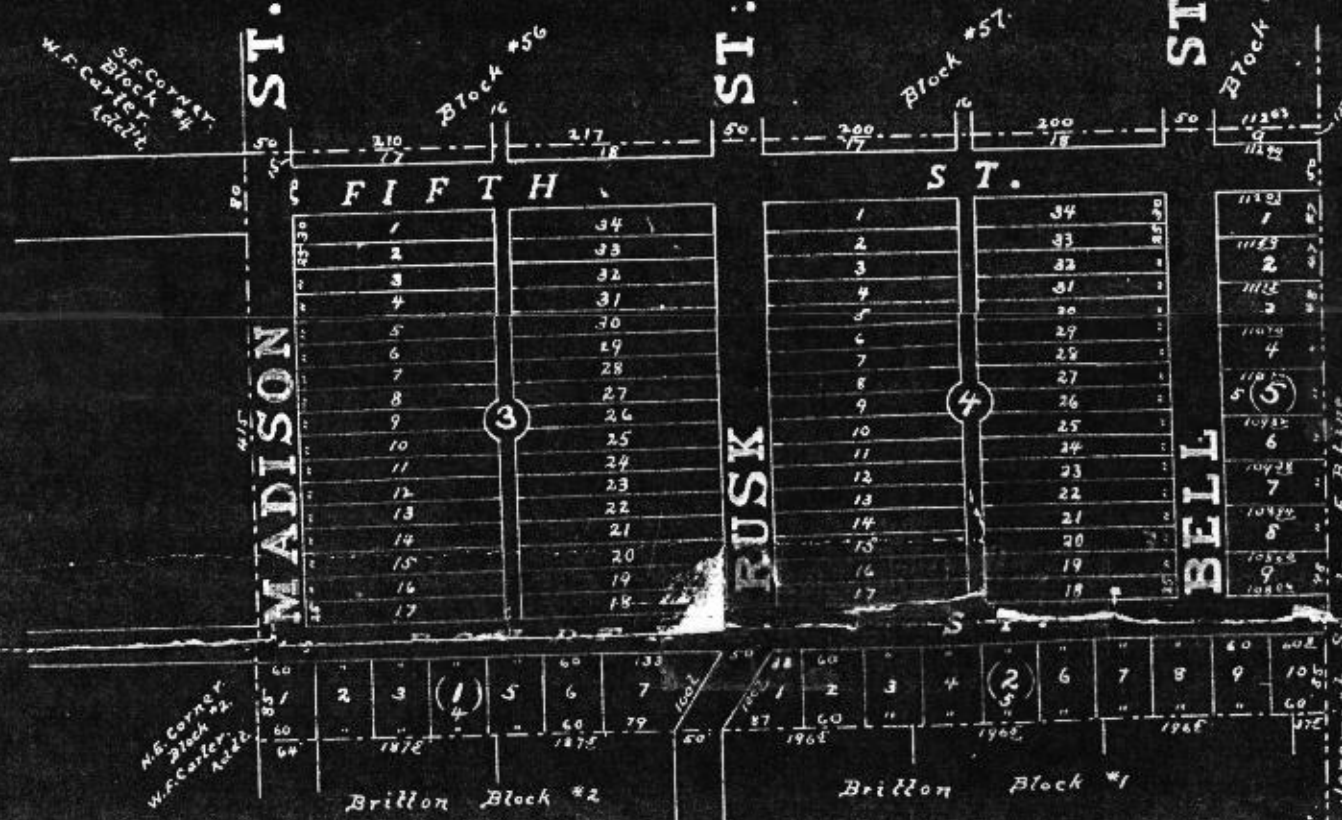


PATTERSON ADDITION TO WEATHERFORD TEXAS
