BEGINNING at a spike found at the Southwest corner of said Lot 46R and the Northwest corner of Lot 45R;
THENCE N 00°27'25" E, with the West line of said Lot 46R, at 370.00 feet passing the Northwest corner of said Lot 46R and the Southwest corner of said Lot 47A, and continuing with the West line of said Lot 47A, passing the Northwest corner of said Lot 47A and the Southwest corner of said Lot 47B and continuing in all, 870.28 feet to a spike found at the most Westerly Northwest corner of said Lot 47B;
THENCE N 88°45'20" E, with the most Westerly North line of said Lot 47B, 56.12 feet to a 1/2" iron found at an ell corner of said Lot 47B;
THENCE N 00°24'08" W, with the most Northerly West line of said Lot 47B, 132.84 feet to a 3/8" iron found at the Northwest corner of said Lot 47B and being in the South line of Baggett Road;

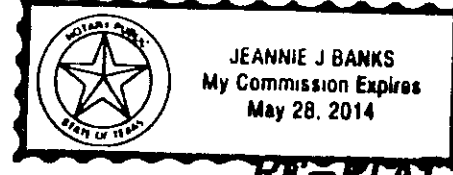
