

FIELD NOTES

FIELD NOTES of a 0.867 acre tract of land being a part of the TIMOTHY FLANNIGAN Survey, Abstract 1743, said tract of land being conveyed to Ralph Shaw according to the deed recorded in Volume 1528, Page 625, of the Deed Records of Parker County, Texas, and being more fully described by metes and bounds as follows:

BEGINNING at a found steel pipe, said point being the intersection of the NBL of Fourth Street and the EBL of King Street;

THENCE N 00 deg. 32 min E, with the EBL of said King Street, 266.0 ft. to a set steel rod for a corner;

THENCE N 89 deg. 54 min. E, 142.0 ft. to a found steel rod for a corner;

THENCE S 00 deg. 32 min. W, 266.0 ft. to a found steel rod in the NBL of said Fourth Street, for a corner;

THENCE S 89 deg. 54 min. W, with the NBL of said Fourth Street, 142.0 ft. to the point of beginning and containing 0.867 acre (37,769.70 sq. ft) of land, more or less.


