OWNERS CERTIFICATE

STATE OF TEXAS COUNTY OF PARKER !

WHEREAS, I, R. L. Barbee, Trustee, am the sole owner of a tract of land situated in the T. and P. R. R. Company Survey 1, Block 2, Abstract 1499, County of Parker, being a part of the properties recorded in Volume 663 Page 504 and Volume 631 Page 598. D.R.P.C.T., and more particularly described as follows:

BEGINNING at an iron pin in the Northwest corner, said pin being North 919.65 feet and North 54 degrees 17 minutes 42 seconds East 1,386.53 feet from the Southwest corner of the T. and P. RR. Company Survey, Abstract 1499;

Thence North 54 degrees 17 minutes 42 seconds East a distance of 379.05 feet to a point for corner;

Thence East 899.95 feet to a post for corner;

Thence South 00 degrees 07 minutes 56 seconds West a distance of 1,848,43 feet to a post for corner;

Thence North 78 degrees 23 minutes 40 seconds West a distance of 593,92 feet to an

Thence North 77 degrees 23 minutes 41 seconds West a distance of 320.56 feet to an angle point;

Thence North 87 degrees 01 minutes 43 seconds West a distance of 362.45 feet to an iron pin for corner;

Thence North 10 degrees 26 minutes 17 seconds East a distance of 558.62 feet to an iron pin for corner, said point being in the South right-of-way line of the cul-de-sac of an existing county road (Woodcrest), said cul-de-sac having a radius of 40.00 feet;

Thence Easterly, Northerly, and Westerly along the right-of-way line of said cul-de-sac, an arc length of 155.32 feet, said arc subtending a central angle of 222 degrees 28 minutes 46 seconds, to the point of reverse curve of a curve to the right having a central angle of 21 degrees 22 minutes 54 seconds and a radius of 250.58 feet;

Thence along said curve a distance of 93.51 feet to the point of tangency;

Thence North 81 degrees 02 minutes 11 seconds West a distance of 84.01 feet to an iron pin for corner;

Thence North 08 degrees 24 minutes 42 seconds East a distance of 794.28 feet to the PLACE OF BEGINNING and containing 48.01 acres, more or less.

THAT, I, R. L. Barbee, Trustee, being the sole owner do hereby adopt this plot designating the hereinabove described real property as Woodcrest Subdivision to Parker County, Texas, and I do hereby dedicate to the public's use the streets and easements shown thereon.
