**A veteran that receives a 100% disability rating due to a service connected disability is eligible to receive an exemption in the amount equal to 100% of their taxable value. This exemption is also available to their surviving spouse as long as the veteran qualified at the date of their death.*

**Further exemptions are also available for for the surviving spouse of a first responder killed in the line of duty.*
