The Public Funds Investment Policy was presented for review. Bret Meekins made a motion to accept the Public Funds Investment Policy as presented. Motion was seconded by David Fenoglio and approved by all members present.

The Emergency and Disaster Policy was presented for review. A motion to accept the Emergency and Disaster Policy as presented was made by Bret Meekins, seconded by David Fenoglio and approved by all members present.
