The Montague County Tax Appraisal District Board of Directors met in regular session on Wednesday, December 4, 2024 at 3:30 p.m. in the Montague County Tax Appraisal District Meeting Room.

A quorum was determined present and the meeting called to order by David Fenoglio. Members present were David Fenoglio, Bret Meekins, Randy West, and Trent Myers. Kathy Phillips was not present.

Holidays for 2025 were presented for approval. A motion to accept the 2025 Holidays as presented was made by Trent Myers, seconded by Randy West and approved by all members present.

Chairman, David Fenoglio opened a proposed Audit Contract for fiscal years 2024 – 2025 from Edgin, Parkman, Fleming & Fleming, PC. A motion by Bret Meekins and seconded by Randy West was made to accept the contract for fiscal years 2024 – 2025 as proposed by Edgin, Parkman, Fleming & Fleming, PC. All members present approved the motion.

Members of the Agriculture Advisory Committee up for 2025 - 2026 term were discussed. A motion to reappoint Justin Hansard and Ben Robbins to the Agriculture Advisory Committee for the 2025 - 2026 was made by Randy West, seconded by Trent Myers and approved by all members present.

The 2024 Appraisal Budget was reviewed.

The Emergency and Disaster Policy was presented for review. A motion to accept the Emergency and Disaster Policy was made by Bret Meekins, seconded by Randy West and approved by all members present.

Chief Appraiser, Kim Haralson gave the following report:

The arbitration that was filed August 6, 2024 has been determined in the favor of the Appraisal District.

Current Collections are at 12%.

Tammie Messer and Ruth Sheppard are currently doing rechecks in Nocona.

Western Valuation & Consulting has finished appraising in Saint Jo and will be starting in Forestburg soon.
