Kim Haralson presented the Chief Appraiser's Report:

- Reappraisals for 2025 have started. Gage Smith with Western Appraisal & Consulting is working in Bowie ISD. Tammie Messer & Ruth Shepard are working on rechecks for the county.
- DCP has filed a lawsuit for 2025.
- Tax statements will be mailed in October 2025.
- New signs have been purchased for doors restricting access to the public.
- As of September 10, 2025, 97.8% taxes have been collected for the 2024 tax year.
- The Texas Legislature has added a new acknowledgement requirement for Board of Directors to be signed prior to being nominated to serve on the board. David Fenoglio, Bret Meekins, Randy West, and Trent Myers signed the acknowledgement for the 2026-2027 Board of Directors. Kathy Phillips, Montague County Tax Assessor-Collector will continue to serve on the board as a non-voting member.

A motion to adjourn was made by Randy West, seconded by Kathy Phillips and approved by all members present.
