The Comptroller's office provides this sample worksheet to assist taxing units in determining tax rates. The information provided in this worksheet is assistance and not legal advice. Taxing units should consult legal counsel for interpretations of law regarding tax rate preparation and adoption.

STEP 1: Effective Tax Rate Activity (No New Taxes)

The effective tax rate enables the public to evaluate the relationship between taxes for the prior year and for the current year based on a tax rate that amount of taxes (no new taxes) if applied to the same properties that are taxed in both years. STEP 2: Rollback Tax Rate

Most school districts calculate a rollback tax rate that is split into two separate rates:

- Maintenance and Operations (M&O): School districts must use the lesser amount of the following methods to calculate the M&O r
 Four cents (\$0.04) PLUS current year's compression rate multiplied by \$1.50 (usually \$1) PLUS any additional cents approved by vc subsequent rollback election; OR
- Current year's compression rate multiplied by six cents (usually four cents) PLUS effective M&O rate which includes school formula Tax Code 26.08(n)
- 2. Debt: The debt tax rate includes the debt service necessary to pay the school district's debt payments in the coming year. This rate interest on bonds and other debt secured by property tax revenue.

In most cases the rollback tax rate exceeds the effective tax rate, but occasionally decreases in a school district's debt service will cau be higher than the rollback tax rate.

A school district may raise its rate for M&O funds used to pay for a facility, device or method for the control of air, water or land pollution. This include building, installation, excavation, machinery, equipment or device that is used, constructed, acquired or installed wholly or partly to meet or exceed portion of district's expenses are those necessary to meet the requirements of a permit issued by the Texas Commission on Environmental Quality must provide the tax assessor with a copy of the TCEQ letter of determination that states the portion of the cost of the installation for pollution control

This step should only be completed by a school district that uses M&O funds to pay for a facility, device or method for the control of air, water or land
