## Taxing Units Other Than School Districts or Water Districts

**GENERAL INFORMATION:** *Tax Code Section 26.04(c)* requires an officer or employee designated by the governing body to calculate the effective tax rate. These tax rates are expressed in dollars per \$100 of taxable value calculated. The calculation process starts after the chief appraiser delivers to the taxing estimated values of properties under protest.

School districts do not use this form, but instead use Comptroller *Form 50-859 Sample Tax Rate Calculation Worksheet for School Districts*.

Water districts as defined under *Water Code Section 49.001(1)* do not use this form, but instead use Comptroller *Form 50-858 Sample Water District Rollback Tax Rate Worksheet*.

The Comptroller's office provides this sample worksheet to assist taxing units in determining tax rates. The information provided in this worksheet is offered as advice. Taxing units should consult legal counsel for interpretations of law regarding tax rate preparation and adoption.

### SECTION 1: Effective Tax Rate (No New Taxes)

The effective tax rate enables the public to evaluate the relationship between taxes for the prior year and for the current year based on a tax rate that would be applied to the same properties that are taxed in both years. When appraisal values increase, the effective tax rate should decrease.

The effective tax rate for a county is the sum of the effective tax rates calculated for each type of tax the county levies.

**SECTION 2: Rollback Tax Rate Activity**

The rollback tax rate is split into two separate rates:

1. **Maintenance and Operations (M&O):** The M&O portion is the tax rate that is needed to raise the same amount of taxes that the taxing unit levied in the prior year plus eight percent. This rate accounts for such things as salaries, utilities and day-to-day operations.

2. **Debt:** The debt tax rate includes the debt service necessary to pay the taxing unit's debt payments in the coming year. This rate accounts for principal and interest on bonds and other debt secured by property tax revenue.

The rollback tax rate for a county is the sum of the rollback tax rates calculated for each type of tax the county levies. In most cases the rollback tax rate decreases in a taxing unit's debt service will cause the effective tax rate to be higher than the rollback tax rate.

**SECTION 3: Additional Sales Taxes to Reduce Property Tax**

Cities, counties and hospital districts may levy a sales tax specifically to reduce property taxes. Local voters by election must approve additional sales tax. If approved, the taxing unit must reduce its effective and rollback tax rates to offset the expected sales tax revenue.

This section should only be completed by a county, city or hospital district that is required to adjust its effective tax rate and/or roll additional sales tax.

**SECTION 4: Additional Rollback Protection for Pollution Control**

A taxing unit may raise its rate for M&O funds used to pay for a facility, device or method for the control of air, water or land pollutant building, installation, excavation, machinery, equipment or device that is used, constructed, acquired or installed wholly or partly to meet requirements. The taxing unit's expenses are those necessary to meet the requirements of a permit issued by the Texas Commission on Environmental Quality (TCEQ). The taxing unit must provide the tax assessor with a copy of the TCEQ letter of determination that states the portion of the total tax rate that is for pollution control.

This section should only be completed by a taxing unit that uses M&O funds to pay for a facility, device or method for the control of air, water or land pollutant building, installation, excavation, machinery, equipment or device that is used, constructed, acquired or installed wholly or partly to meet requirements.
