**MEMO #1:**

- (1) Miles ISD & Water Valley ISD conducted rollback tax rate elections on November 4, 2008.
- (2) The Miles ISD Rate passed and the Water Valley ISD rate failed.
- (3) Christoval ISD conducted a rollback tax rate election on December 16, 2008. Rate Passed.
- (4) Water Valley ISD conducted rollback tax rate elections on July 20, 2010. Rate Passed.
- (5) Miles ISD passed a bond election that increases the I & S tax rate beginning 2015.

**MEMO #2:**

- (1) Grape Creek I.S.D. eliminated the optional 20% homestead exemption for 1999.
- (2) Irion County Water Conservation District was new for 2001.
- (3) Sterling County Water Conservation District was new for 2002.
- (4) Wall I.S.D. eliminated the optional 20% homestead exemption for 2004.
- (5) City of San Angelo implemented the Over 65 & Disabled Freeze beginning with 2004.
- (6) City of San Angelo eliminated the \$12,500 Over Age 65 exemption for 2005.
- (7) Miles I.S.D. "TGC Part" was a new taxing unit for TGCAD for 2008 tax year. The 2007 taxes for Runnels & TGC were levied & collected in Runnels County until July 1, 2008.
- (8) San Angelo I.S.D. eliminated the optional 20% homestead exemption for 2012.
- (9) Veribest I.S.D. reduced the optional homestead exemption from 20% to 10% for 2013 and 2014. and eliminated the optional exemption for 2015.
- (10) Water Valley I.S.D. eliminated the optional 20% homestead exemption for 2013.
- (11) Christoval ISD eliminated the 20% optional homestead exemption for 2015.
