The Montague County Agriculture Advisory Committee met Friday, May 5, 2023 at 9:00 a.m. in the Montague County Tax Appraisal District Meeting Room.

The meeting was called to order by President, Justin Hansard.

Members present were Justin Hansard, Don McLaughlin, Ben Robbins and Chief Appraiser, Kim Haralson.

Oaths of office were administered to Justin Hansard and Ben Robbins.

Election of officers was held. Don McLaughlin nominated Justin Hansard for president. Ben Robbins seconded the motion. All members approved the motion. Don McLaughlin nominated Ben Robbins for secretary. Justin Hansard seconded the motion. All members approved the motion.

The 2023 Agricultural value computations were presented by Chief Appraiser, Kim Haralson. The lease information is provided by Agricultural Appraisal Applications, Montague County Extension Agent and Farm Service Agency. The agricultural land cap rate of 10% used in the computations is provided annually by the Texas Comptroller of Public Accounts. The following 2023 agricultural values were presented:

Dry Cropland	\$161.00 per acre
Improved Pasture	\$ 82.00 per acre
Native Pasture	\$ 46.00 per acre
Accretions	\$ 46.00 per acre
Barren (1/2 Native)	\$ 23.00 per acre

A motion to approve the 2023 Agricultural Values as presented was made by Don McLaughlin, seconded by Ben Robbins and approved by all members present.

Kim Haralson presented the 2023 Agricultural Use Booklet. Discussion was held reviewing land size, qualification requirements, degree of intensity and wildlife management. No changes were recommended. Motion to accept the document as presented was made by Ben Robbins, seconded by Don McLaughlin and approved by all members present.
