The changes to the budget from 2016 are as follows:

- 1. PAYROLL Increase due to health insurance and retirement cost. Retirement rate went up to 8.08% from 7.17% due to changes in the market returns.
- OFFICE SUPPLIES This expense has increased the past two years. Budgeting accordingly for 2017.

In summary the 2017 Wise County Appraisal Budget for Collection Services is up slightly from 2016 and allocation amount will increase \$4247. Final allocation amounts are attached.
